Call to Order

Ivy Whitlatch, Chair, called the meeting to order at 7:03 p.m.

Reading of Virtual Meeting Notice City of Alexandria by Garrett Fesler and recorded by Emma Richardson.

Review and Approval of Minutes

AAC members reviewed the Wednesday, February 16 meeting minutes. Ann Greer moved to accept the minutes, as amended. Ralph Rosenbaum seconded. Motion passed and minutes approved, as amended.

Chair Report – Ivy Whitlatch

Ivy thanked AAC members who walked in the George Washington Birthday Parade on Monday, February 21 and Emma shared photos. This was the biggest turnout of AAC members in recent memory.

HARC Update: The advocacy committee of HARC, in conjunction with Al Cox, has prepared a letter to the head of the Board of Architectural Review in order to persuade them to nominate the Torpedo Factory building to the National Register of Historic Places.

City Council Packets - Ivy shared the preliminary success of the packets, as she has had one "meet and greet" call with Councilman Canek Aguirre. Aguirre is supportive and thinks Alexandria Archaeology needs more exposure. On Tuesday, March 15, Ivy, Garrett, and Eleanor Breen, City Archaeologist, met with Councilmember Sarah Bagley at the Alexandria Archaeology Museum for a "meet and greet." Councilmember Bagley was supportive and fascinated with the City's archaeological program and upcoming projects. Meetings with Councilmembers R. Kirk McPike and Alyia Gaskins are scheduled for March and April, respectively.

AAC Ordinance Update - Ivy Whitlatch

Select Awards Committee and Chair - Ivy Whitlatch

AAC continued discussions around the creation of an award in addition to the annual Ben Brenman Award. Types of potential recipients and the presentation of such award were also shared.

Planning Updates and Reports

Waterfront Commission – Esther White

- Esther reported that Eleanor presented Alexandria Archaeology's plans for the ship ponding to the Waterfront Commission at its Tuesday, March 15 meeting.
- In preparation for the Flood Mitigation update from Matt Landes of the City's Department of Project Implementation, at next month's AAC meeting, Ivy and Esther asked the AAC to review the materials Eleanor sent to the AAC via email and submit any questions to Ivy prior to the April meeting. Ivy asked Garrett if he could put together info for AAC on how Landes and Alexandria Archaeology have already worked together on this project/history of Founder's Park. Garrett agreed.

African American Heritage Trail Committee – Ted Pulliam

• Ted reported that this Committee reviewed final written comments on the interpretative markers for the last part of the Trail's southern end. The Committee will meet in April to create a final draft.

FOAA Update - Dick Owens

- Dick shared that FOAA members were appreciative of the collaboration with City staff and AAC in the logistics for and marching in the George Washington Birthday Parade on Monday, February 21.
- FOAA started to plan for the annual volunteer party, which will be in April.
- FOAA continued to work with City staff in preparation for the ship ponding and ship models exhibition at the Archaeology Museum/Torpedo Factory Art Center (TFAC).

Visit Alexandria - Rebecca Doser

- Rebecca noted that there are national media visits to the city this spring, with some expressing interest in Black history and culture in Alexandria. She intends on pointing their attention to the African American Heritage Trail. Seth Tinkham also recommended Contrabands and Freedmen Cemetery Memorial and its inclusion in the African American Civil Rights Network.
- Rebecca is following the opening of the Freedom House, as opening has been pushed back from April to Memorial Day weekend. Ivy media might be interested in the ship exhibits.
- Rebecca has not had a specific ask from the media about archaeology. Ivy suggested that the media might be interested in the ship exhibit planned for April-June at the TFAC and ship ponding.
