#### **Board of Architectural Review Update: Bill Conkey**

- BAR meeting March 16, lengthy docket
- 615 and 621 King Street Development Project (applying for permit to demolish/capsulate and concept review). Building façade of 615 dates to 1929 and has been heavily modified. 621 façade dates to 1909, the storefront of this property has been modified multiple times but the portions above the first floor remain as originally designed. The project will include ground floor retail with multi-family above. A new fourth floor will be recessed 14' from the King Street facade.
- 912/920 King Street received approvals in place, returning to board for certificate of appropriateness
- 116 Henry Street has received approvals from Council and returns for a Certificate of Appropriateness.
- 10 Duke Street returns to the Board due to an expired approval of a certificate of appropriateness. No changes to the approved design have been made.
