Alexandria Community Remembrance Project – Gretchen Bulova for Mark Farkus

- Oral histories are in progress with members of the ACRP who participated in the October pilgrimage to Montgomery.
- Committees will resume work in the new year

Advocacy – Martha Harris and Martha Raymond, Co-Chairs

- Three items discussed: Torpedo Factory Task Force, Samuel Madden, and Mayor's Commitment to affordable Housing
- Next meeting is December 6.

- Anticipate elections at the December 20 meeting

Open Space – Martha Harris (no report at this time)

Torpedo Factory Stakeholder Group – Martha Raymond

- City Manager asked about ideas for programs and improvement. Discussion ranged from practical improvements to miniature golf on the roof. Full list will be in consultant's notes which can be shared.
- Focused on strong connection with artists, importance of the archaeology museum in the building
- Next meeting December 7, focus on marketing. Intends to discuss commitment to National Register status for the building.

HARC Composition Committee – Michael Hobbs chaired this portion of the meeting

- Committee first established May 2021
- Circulated committee's recent Summary/Worksheet of recommendations in advance of meeting

- Committee's review proceeded from present composition of HARC, shown in the worksheet in the order listed in the ordinance. Committee suggests discussion of its recommendations be grouped according to similar categories and nature of proposed change.
- Recommendations: (Motions and votes taken were for planning purposes preparatory to final overall review and drafting an ordinance revision.)
 - Continuation of 3 City Commission and 7 History Organization seats: Alexandria Archaeological Commission (AAC), Alexandria Historical Restoration and Preservation Commission (AHRPC), Public Records Advisory Commission (PRAC), Alexandria Association, Alexandria Historical Society, Alexandria Society for the Preservation of Black Heritage, Inc. or an equivalent organization, Carlyle House, George Washington Masonic Memorial, Historic Alexandria Foundation, Lee-Fendall House.
 - Motion by Danny Smith and seconded by Linda Lovell to approve this group of 10 organizations for membership in HARC. Motion passed.
 - Torpedo Factory Artists Association seat be continued under History Organization category.
 - Motion by Danny Smith and seconded by Linda Lovell to approve retaining the Torpedo Factory Artists Association seat under the history organization category.
 - Discussion included relevancy in separate "art affiliated groups" category versus history.
 - Motion passed.
 - Broaden eligibility for the Mortar and Pestle Society seat to include "friends" groups or similar volunteer support organizations for any Alexandria historic site or property.
 - Motion by Linda Lovell and seconded by Gail Rothrock to expand the eligibility for friends groups. Motion passed.
 - Broaden the eligibility for two seats now designated for Christ Church and the Old Presbyterian Meeting House to include other "houses of worship";
 - Motion by Danny Smith and seconded by Gail Rothrock to expand the eligibility of representatives of houses of worship, congregations or sites which have played a significant role in the diverse cultural, social, and religious history of the city. Motion passed.
 - o Increase the number of seats in the "historic site volunteer" category from one to two, including the present seat for an individual who serves as a volunteer at a historic property or attraction, and the redefined seat for a member of a friends or support group at a historic site, heretofore limited to the Mortar and Pestle Society.
 - Motion by Linda Lovell and second by Danny Smith to add a volunteer representative to HARC. Motion passed.
 - Discussion on other recommendations will continue at a future next meeting.

Board of Architectural Review Update: Bill Conkey

- BAR appeal, 610 Montgomery Street unpainted masonry and applicant appealing, scheduled for December City Council hearing.
- BAR assigned members to committees to replace those members lost due to changes in the Board roster.
- BAR Design Guidelines committee scheduled to meet 11/29
- Scheduling board training for new members

OHA Report: Gretchen Bulova

- Staff are planning for the arrival of the Lord and Lady Provost of Dundee, Scotland. They will be touring the city and participating in the Scottish Walk Weekend Events.
- Staff are preparing for the American Alliance of Museums Accreditation Site Visit December 7 to 9. Three-day site visit will include touring all the museums and historic sites, visiting storage, observing educational programs, and meeting with elected and city officials.
- Murray-Dick-Fawcett House
 - o Glave-Holmes was awarded contracts for both the Historic Structures Report and the Master Plan.
 - The current restoration is focused on the east façade and stabilization of the Prince Street entrance porch.
- A new exhibit at the Alexandria History Museum at The Lyceum, "Alexandria Hospital: Women Mobilize the Community," opened on October 27.
- Community engagement will begin as part of the master planning process for Freedom House. The contract was awarded to Smith Group. A representative from HARC will have the opportunity to participate in the master planning.
