Torpedo Factory Stakeholder Group – Martha Raymond

- December 7, most recent meeting, was attended by the City Manager and he is interested in immediate improvements that would have impact on the visitor experience at the TFAC.
- Discussion about improvements that don't impair the historic fabric of the building included a new waterfront entrance and specialty lighting.
- The Archaeology Museum's continuation at the TFAC was discussed.
- The National Register Nomination for the TFAC was not addressed at the meeting. The City Manager requested that HARC bring this to his attention directly, with the assistance of City staff.
  - Motion was made by Martha Harris and seconded by Gail Rothrock to send a letter to the City Manager requesting a meeting to discuss the National Register Nomination for the TFAC and its importance. Motion passed.
  - The Advocacy Committee was asked to draft a letter.
  - Suggested if a meeting opportunity is granted that a PowerPoint presentation be prepared to provide concise, efficient presentation of key points and to leave a written document of the points with the City Manager

Open Space – Martha Harris

• Sam Hoffman has agreed to be the new HARC representative to the Open Space Committee.

HARC Composition Committee – Michael Hobbs chaired the discussion

- Recommended changes to continue discussion started at November meeting:
  - Discontinue the specifically designated seats for ACVB (now ACVA), the Alexandria Chamber of Commerce, and the Northern Virginia Fine Arts Association.
- To meet the objective of representing tourism as a function of HARC, it was recommended that the business representative seats serve in this capacity (tourism and business). It was also offered that the museums and friends of the museums also serve to represent the tourism industry.
  - A question was asked about the intent and goals to reduce the number of seats on the commission.
  - Motion to have 2 members represent the tourism and business community was made by Danny Smith and seconded by Shawn Eyer. Discussion took place about eliminating the specific organization designations. The motion passed.
- Committee recommended to eliminate the seat designated for the Northern Virginia Fine Arts Association.
  - Motion made by Danny Smith and seconded by Martha Harris to reject the committee recommendation to delete the seat for the Northern Virginia Fine Arts Association. Discussion took place. The motion passed.
- Next meeting: Recommendation to potential reduce seats for the Planning District Commissions and the Civic Associations.

### **Board of Architectural Review Update: Bill Conkey**

- 319 N Alfred Street is on the docket for 12/21/2022. This is an after the fact approval for HVAC piping installed on the exterior of the north wall. Staff is recommending denial.
- The BAR hearing on 1/4/2023 is cancelled due to a lack of cases. The second meeting should be busy.
- Diversity training for the BAR Board is planned for 2023. This was a recommendation for the BAR's annual retreat.

# **OHA Report: Gretchen Bulova**

- Staff participated in a three-day site visit for museum reaccreditation.
- A survey for Freedom House is now open. This information will be used in the master planning process for the site.
- Murray-Dick-Fawcett House
  - The restoration on the east façade and stabilization of the Prince Street entrance porch is wrapping up.
  - Next items include replacing the existing gates and renewing the woodwork on the 1970s garage.

• The FY22 Annual Report for OHA was distributed to HARC members, calling attention to the numerous projects that were managed and completed this year.
