Board of Architectural Review Update: Bill Conkey

- The columbarium at the St. Mary's Cemetery was recently approved by the BAR. This application was previously approved but that approval expired. In the new application the design was slightly modified.
- The BAR recently accepted a deferral for the after-the-fact approval of HVAC piping installed at the exterior of the structure. Staff is currently working through potential options with the applicant.
- The BAR Design Guideline Committee will be holding a meeting in February. This is part of a regular series of meetings meant to update the current guidelines.

OHA Report: Gretchen Bulova

- Mary Bramley, our new Development Officer, started January 9th. I hope to introduce her to you at a future meeting.
- Need a HARC representative to the Master Planning process for 1315 Duke Street, participation involves one three-hour workshop in March. (Donna DeBlasio volunteered to be the representative)
- Our museums are on winter hours now, so shorter days. Please check the website for the exact details. Remember that City of Alexandria residents receive complimentary admission for the regular tours.
- Planning to reopen the Black History Museum in February with a new exhibition, *Black Lives Remembered*.
- WW1 interpretive marker installed by monument at the train station.
- This spring, planning to update the timeline inside the Torpedo Factory Arcade

- Launch of the southern route of the Waterfront African American history trail will be held at The Lyceum on Saturday, February 4th.
- Murray-Dick-Fawcett House exterior renovation is nearing completion. Should probably be finished before our next HARC meeting! Interior ceiling plaster repairs are scheduled for early February.
- George Washington Parade will be held on Monday, February 20th the route is new this year to partner with the Masonic Memorial's 100 Commemoration of the corner stone laying.
- Consultants have studied the water drainage issue at Douglass Cemetery and have offered potential solutions. Staff are working with a company to determine the stability of a pipe that spans the cemetery, originally installed around 1904.
- Planning Black History Month, George Washington Month, as well as Women's History Month activities.

- The Chair also expressed thanks to Martha Harris for her 10 years of service on HARC. Martha was presented with flowers and a plaque.
