- Confirmed that a letter was sent to the City Manager on January 31 regarding the TFAC National Register nomination.

Torpedo Factory Stakeholder Group – Martha Raymond

- Final meeting was held February 15, summary of branding, facility maintenance, and governance meetings
- Has budgeted \$1M for deferred maintenance in FY24
- City Manager thanked the task force provided him with good information and guidance, understands that the facility is beloved, plans to tap into the expertise on the task force in the future

- Ivy took issue with the executive summary in the power point presentation prepared by the consultants, which highlighted the TFAC only as an arts center (no mention of history or archaeology)

Board of Architectural Review Update: Bill Conkey

- A meeting of the Design Guidelines Committee was held this morning to continue updating the 1992 Design Guidelines. We have another meeting tentatively scheduled for March 21, 2023. We will publish this date once it has been finalized.
- With Spring weather approaching we are renewing our call for volunteers to help with the Digital Architectural Survey of the Old and Historic Alexandria District. Volunteers will be asked to help documents properties within the historic district using photography and GIS mapping.
- 1101 King Street will be on the docket for the BAR on March 2, 2023. This is the conversion of the office building at the northwest corner of Henry and King Street into a multi-family residential building. The proposed modifications to the exterior are relatively minor and staff is supporting the proposed design.
- The third Section 106 Consulting Parties meeting for the Samuel Madden Redevelopment will take place on February 23, 2023 in person at the Charles Houston Recreation Center at 10:00 a.m.

OHA Report: Gretchen Bulova

- Big news is that after more than 3 years, our departmental reorganization is now official and staff will be moving into teams by function rather than site. We have created a new division of African American History and Audrey Davis will be leading this initiative. Several positions will be advertised including the Deputy Director, Assistant Director for African American History, Curator for African American History, and Preservation Manager. This reorg creates new positions and moves several staff members to full time. It is within our same budget and FTE count.
- VAM (Virginia Association of Museums) Top 10 objects contest is now taking place. Between Feb 20 and March 3, please vote with your email address to help us win up to \$1000 in conservation prize money for *"George Seaton's Bible," 1853. It is currently on view at the Freedom House Museum.* George Seaton was the first African American member of the Virginia General Assembly and an early educator for African Americans in Alexandria. Additionally, he was a member of the grand jury that indicted Jefferson Davis. His 1853 Bible with its burgundy velvet cover and clasped metal edging survives, but the velvet is worn and detaching on the spine. The front and back cover are also detached. Conservation will stabilize this tangible legacy of a groundbreaking African American leader.
- Master Plan for Freedom House will be starting next week with two workshops led by Smith Group. Donna DeBlasio will represent HARC in these meetings.

- Black History Museum will reopen this weekend, February 26th with a new exhibition, *Black Lives Remembered*. An open house on February 26 will take place 2 to 5 p.m. All are welcome and an rsvp to the museum is appreciated.
- We will know the results of our AAM re-accreditation on March 15 and will share the news with you.
- We will be launching Women's History Month activities in March and planning events for Historic Preservation Month in May.

<u>Public Comment</u>: Al Cox offered comments about the Samuel Madden development and shared his comments that were provided in a letter to the Mayor. Affordable housing and historic preservation should be complimentary moving forward.
