Ad-Hoc HARC Composition Committee – Michael Hobbs (presenting for the Committee to succeed Richard Klingenmaier, who did not apply for reappointment to HARC in January)

- Brief review of the goals and progress made to date
- Review of the number of planning district representatives
  - Motion by Tom Soule to reject the Committee proposal to reduce the number of planning district representatives, seconded by Martha Raymond. Discussion about the role and need for these representatives. Motion passes.
- Review of civic association representatives
  - Motion by Danny Smith to adopt the Committee proposal to reduce the representatives from 2 to 1 and seconded by Tom Soule. Discussion about planning district and civic association representatives sharing 7 at-large positions. Motion fails.
- Recommendation by Sam Hoffman to increase the at-large positions to 8 representatives. This will be discussed next month.

Ad-Hoc Proposed Street Naming Committee – Linda Lovell and Mark Farkas, Co-Chairs

#### **Board of Architectural Review Update: Report submitted by Bill Conkey**

- The BAR previously approved the careful de-construction and reassembly of the existing building at 10 Duke Street at a higher elevation and with some modifications. The applicant has satisfied many of the approval requirements related to the documentation of the existing building and is set to begin the de-construction process. As recently noted in the local media, an agreement has been reached with a local restauranteur to develop a new tavern in the space once the construction has been completed.
- The Design Guidelines Committee for the BAR held another working session on March 21, 2023 to continue the work in updating the Design Guidelines. The group will continue to meet regularly with the goal of bringing updated chapters to the full Board for adoption. The committee is meeting on a monthly basis with a goal of completing the guideline update as quickly as possible.
- A new BAR member was appointed by City Council at their recent public meeting. Nastaran Zandian is a resident of the Parker Gray District and is an architect with Cooper Cary. She will be starting with the Board in April.

#### **OHA Report: Gretchen Bulova**
