Ad-Hoc HARC Composition Committee – Michael Hobbs

- Commission completed review of Committee's recommendations at the April 18, 2023 meeting.
- Action needed tonight:
 - o Review tentative conclusions from prior meetings.
 - o Consider the draft ordinance for referral to City Council.

- A summary chart of HARC's present composition and Commission's tentative conclusions was circulated to commissioners in advance of the meeting.
- Motion by Tom Soule to confirm the Commission's tentative conclusions as HARC's action on its proposed composition, seconded by Sean Ferguson. Motion passed.
- Michael Hobbs recommended forwarding a draft ordinance along with the Commission's report to the City Clerk's office for consideration by City Council.
- Motion by Danny Smith to accept and endorse the draft ordinance as reflective of HARC's intent to adjust the composition of the commission, seconded by Gail Rothrock. Motion passed.

- Attended May 1 Open Space meeting, which was the final meeting for that committee.
- Zoning ordinance includes open space requirements. The Open Space Steering Committee was created to proactively re-examine the ordinance to preserve open space.
- Ordinance now includes information on preserving and protecting the City's historic resources and the "character of open space."
- New alternatives include donations to an open space fund, in lieu of actual open space.
- June 6, recommendations going to Planning Commission.
- Community engagement on the Open Space Plan is taking place.

Board of Architectural Review Update: Report submitted by Bill Conkey

- 10 Duke Street The de-construction of the existing building is underway. They have removed the roof and most of the exterior walls at the second floor. I visited the site today and the builder is doing a good job of carefully protecting the existing material so that it can be reassembled at a higher elevation. They now have a tenant for the building and are moving forward with building it per the original BAR approval.
- 114 North Payne Street City Council upheld the decision of the BAR to allow modifications to the property at 114 North Payne Street. Modifications include changes to the front elevation, a second-floor rear addition, and additional paying in the front yard to accommodate additional parking.
- 301 North Fairfax Street The Board will hear a request for a Permit to Demolish and a Concept Review for the replacement of the existing office building at the northeast corner of North Fairfax and Queen Street with a new multi-family residential building.

OHA Report: Gretchen Bulova

- Hot off the press news Liz Williams has been selected as OHA's Deputy Director. She has been with Gadsby's Tavern Museum for 18 years, the last 7 as Director.
- Spring2Action, held April 26th, was very successful and raised \$17,000 for Historic Alexandria. Thanks to everyone who donated and attended our fundraising happy hour event.
- May is Historic Preservation Month! Al Cox gave a terrific lecture on May 9th at The Lyceum on the exterior restoration of the Murray-Dick-Fawcett House. The lecture was recorded and will posted on the MDF web page. Specialty tours called "Peeling Back the Layers" continue to be offered at Gadsby's each Saturday morning in May, 9:30-10:30 a.m. that will explore the building's architecture, including going into spaces not typically open to the public.
- We will cap Historic Preservation Month off with an AAM accreditation celebration on Tuesday, May 30th from 5 to 7 p.m. at The Lyceum. Please join us!
- Site updates:
 - Historic Structures assessment by Glave Holmes will begin next week at the Murray-Dick-Fawcett House.
 - Archives and Records Center will be undergoing an extensive renovation. The contract has been awarded and the work will begin shortly. This does involve relocating collections.
 - Contract to restore the Fort Ward Ceremonial Gate has been awarded to Oak Grove Restoration and the work will begin early summer.

- o Alexandria Archaeology has installed new exhibit panels on their Lee Street excavations, with funding support from HAF.
- o Conservation of the historic pumper at Friendship Firehouse is going well and we hope to see the historic fire engine return in August.
- o Unfortunately, the heavy rains last week caused a lot of basement water damage at the Black History Museum. The affected area is being remediated.

The Historic Alexandria Resources Commission meeting was adjourned at 9:10 p.m. The next meeting will take place on June 20, 2023, at the Lloyd House.
