New Business:

- Motion by Carol Black to require any written material that is to be discussed at the

Old Business:

- HARC composition change

Ad-Hoc Proposed Street Naming Committee – Linda Lovell and Mark Farkas, Co-Chairs

- Linda Lovell made a presentation on behalf of HARC at the City Council Naming Committee meeting on Thursday, September 28. She explained HARC's process for the names submitted to the Naming Committee. Council members thanked HARC for their thoughtful work.
- Six street names were selected for the initial process: N. Breckinridge Place, N Frost, N/S Early, N/S Jordan, Jordan Place, and Forrest.
- Possible replacement names: Benjamin Banneker, Sarah Gray, Ona Judge, Harriet Jacobs, Hughes, and Forest.
- It was proposed that Jordan be changed to Hughes, a family that was enslaved in the Foxchase area and that Forrest be changed to Forest.
- Next public meeting will be November 30 at 6 p.m. in City Hall. Public comment will be welcome. Information about the street name change process is available online.
 Materials are available in multiple languages.

Board of Architectural Review Update: Bill Conkey

• Samuel Madden

After the DSUP was approved by City Council, the BAR reviewed the request for a Certificate of Appropriateness for the two buildings included in the Samuel Madden Project. At the first hearing, the Board made comments on the proposal including the

design of the gateway element at the north end of the north building, the design for fiber cement panels throughout, and a request that the applicant propose windows that comply with the BAR policies on new and replacement windows. The applicant made each of the requested revisions and the Board approved the Certificate of Appropriateness at the October 4, 2023 hearing.

• King Street Condos

At the October 4, 2023, hearing the Board provided feedback on a Concept Review for the development of a multi-family project at 1604-1614 King Street. The project includes the demolition of all but the facades at the existing townhouses at 1604-1612 King Street, the complete demolition of the townhouse at 1614 King Street, and the construction of a multi-family building at the south end of the project site, behind the townhouses. The Board provided guidance related to the extent of demolition and the height, scale, mass and character of the proposed project. Some Board members expressed concern regarding the extent of demolition but asked the applicant for additional information prior to a request for a Permit to Demolish. The Board provided guidance on the development of the character for the new multi-family building.

• Design Guidelines

At a recent BAR hearing, members of the Design Guidelines Committee presented the proposed template and the first round of reformatted Design Guideline chapters. The Board provided feedback on the design of the template and made comments regarding the content of the chapters. The Committee has revised those chapters and will be taking them to the Board for a vote at the November 2, 2023, hearing.

OHA Report: Gretchen Bulova

- Pleased to report that OHA received a Virginia Tourism Corporation grant in the amount
 of \$10,000 to support two interpretive signs (Fairfax County Resolves and Lafayette visit
 in 1824) and dedication events as part of VA250. These events will be held in
 collaboration with Mount Vernon, Gunston Hall, Carlyle House, and the American
 Friends of Lafayette.
- Working on a "rescue" mission with the Special Collections Division of the Alexandria Library to preserve bound volumes of the Gazette that were being damaged at the Alexandria Gazette offices. The volumes are as old as 1803 but do not include the years of the Civil War.
- Dedication of a plaque in honor of former councilwoman Lois Walker will take place at the Alexandria Train Station on Sunday, October 29 at 4 p.m. This will honor her work with rail transportation in the City. All are welcome.
- Tomorrow, easement review by the Virginia Department of Historic Resources of 1315 Duke Street, Murray-Dick-Fawcett House, and the Lloyd House will take place.
- November 8/9th, students from Gonzaga High School will visit 1315 Duke and then pilgrimage to the waterfront and hold a small ceremony to honor the enslaved man

- Gabriel who was owned by the school. Students researched Gabriel's history and created exhibit panels that will be temporarily on view at 1315 Duke.
- The Lord and Lady Provost of Dundee plan to attend this year's Scottish Walk weekend.
- A few spaces remain for this Friday's Alexandria Forum featuring the latest Waterfront history scholarship. It runs 9 to 5, with a reception at 4 p.m. If you are interested, please register soon at the volunteer rate.
