Board of Architectural Review (BAR) Update: Bill Conkey

• 301 North Fairfax Street - On July 2, 2024, the City Council heard the appeal of the BAR approval for the Certificate of Appropriateness for new construction. The Board was

- represented by the Chair, who described the discussions surrounding their approval. After some discussion, the City Council affirmed the decision of the BAR with the conditions of approval that the Board adopted.
- Robinson Terminal North The Board will be hearing the second concept review for the Robinson Terminal North project at the July 16, 2024 BAR hearing. This project is unique in that it is outside the historic district but the waterfront plan requires that the BAR hold concept review sessions on the design prior to the approval of the Development Special Use Permit. The project will not return to the BAR for a Certificate of Appropriateness. The Board made favorable comments regarding the design at the last hearing and the design has changed to address the comments from staff and the Board.
- Design Guidelines The Board will be considering some modifications to the roof chapter of the Guidelines at the July 16, 2024 BAR hearing. These are minor modifications to the previously approved version that will address some comments that have arisen since their adoption. The Design Guidelines Committee will be working over the Summer on additional chapters including the window chapter, which is one of the most commonly used sections of the guidelines.

OHA Report: Gretchen Bulova, report given by Whitney Umarov on behalf of Ms. Bulova

- HARC members were invited to view four new exhibitions:
 - a. Buried Ships of Robinson Landing, a viewable exhibit morning to evening on Pioneer Mill Way.
 - b. Lewis Cass White: Preserving the Legacy of Fort Stevens, Fort Ward Museum and Historic Site
 - To honor the 160th anniversary of the Battle of Fort Stevens, guests will learn more about Lewis Cass White and his large collection of almost 200 documents, objects, and photographs related to his Civil War service and post-war mission to preserve the Defenses of Washington.
 - c. Mapping Alexandria: Stories of a Changing City, Alexandria History Museum at The Lyceum
 - Block by block, guests will explore the stories of Alexandria. This exhibition, which marks the 275th anniversary of the City's founding, delves into the evolution and history of Alexandria through the words of its residents.
 - d. Moss H. Kendrix: Reframing the Black Image, Alexandria Black History Museum This exhibition debuts the works of African American public relations pioneer Moss Kendrix. In the late 1940s he promoted a new approach in marketing appealing to African American consumers with positive and aspirational advertising campaigns featuring African American models and stars. This exhibition is supported by an IMLS grant.
- Exterior rehabilitation of the Freedom House Museum has started. Scaffolding on the south and west elevations should be installed by mid-July. The museum is open during this renovation work.
