- For the Lee-Fendall House Museum, Shawn reported that the December programs included a Victorian Christmas and an upcoming Kissing Ball Workshop. They are wrapping up their 50<sup>th</sup> anniversary year with the new paint color for the building's exterior and a resolution for the garden wall's repair.
- For the George Washington Masonic National Memorial, Shawn reported that they are focused on February events celebrating Washington's birthday. On Saturday, February 22nd, the large Washington statue will be rededicated for its 75<sup>th</sup> anniversary. President Truman spoke at the statue's dedication on February 22, 1950. Truman's grandson will speak at the 75<sup>th</sup> anniversary rededication. - The AAC will hold an event on January 31, 2025, at the Torpedo Factory to celebrate its 50<sup>th</sup> anniversary. Commissioners are working on national recognition.

### **New Business:**

Nominating Committee Report:

- A call for nominations from the floor was made by Shawn Eyers. No nominations were made.
- A motion was made by Ivy Whitlach and seconded by John Patrick to accept the slate as proposed. The motion was approved.

#### **Old Business:**

Jones Point Lighthouse Update:

- City Staff is working with Chistine Smith, Superintendent, George Washington Memorial Parkway on the maintenance issues. Mayor Justin Wilson was told that the National Park Service did not have the money to make the repairs.
- Carol Black volunteered to contact Mayor-Elect Gaskins to continue the conversation with the Park Service. A motion was made by Carol Black and seconded by John Patrick to update Mayor-Elect Gaskins. The motion passed.

## City Hall Renovation:

- Gail Rothrock attended the third community outreach session that was focused on the redesign of Market Square. The consultants talked about trying to preserve some of the original historic fabric and spaces of City Hall.

### **Board of Architectural Review (BAR) Update: Bill Conkey**

#### 201 Gibbon Street Appeal

 On Saturday December 14, 2024, the City Council heard an appeal of the Board of Architectural Review's denial of a Certificate of Appropriateness for the replacement of two second floor windows on the south elevation of 201 Gibbon Street. The Board denied the request, noting that the subject windows are the last two remaining historic windows on the structure. The Council agreed with the BAR and upheld their decision.

### Waterfront Flood Mitigation

• The BAR will be holding a Concept Review session at their hearing on December 18, 2024, to discuss the proposed design for the redevelopment of Waterfront Park and Point Lumley Park. This will include a proposal for a new pump station to be located in Waterfront Park. At this Concept Review, the Board will consider different options for the design and location of the pump station and the design of each of the two parks.

#### 1007 and 1007A Oronoco Street

• The current property at 1007 Oronoco Street is a single historic structure with empty lots to the east and west. The property owner recently had the subdivision of the single lot into three lots approved by the Planning Commission. The dividing line for the historic district runs immediately to the west of the existing structure, meaning that the modifications to the existing building and the proposed new building to the east of the site will be reviewed by the BAR. They will be reviewed at the December 18, 2024, BAR hearing.

### Office of Historic Alexandria (OHA) Report: Gretchen Bulova

- Thanked everyone for their support and participation in OHA's stakeholder meetings, events, and fundraising activities.
- Wrapping up 2024 it was a busy year of research, exhibits, and programming for the City's 275<sup>th</sup> anniversary.
- There were visits from all three sister cities Dundee, Caen, and Helsingborg.
- The Education team participated in more than 40 outreach events throughout Alexandria.

- Almost 4000 students and teachers have participated in school programs in OHA's eight museums.
- Restoration projects have included new windows/doors at Gadsby's Tavern Museum and the Apothecary, building renewal at the Archives and Records Center, and the exterior rehabilitation of the Freedom House Museum.
- OHA staff oversaw the research, fabrication, and installation of the Fairfax Resolves Road to Revolution Marker, Lafayette Commemoration marker, 11 markers along the waterfront as part of the African American Heritage Trail, and two Vietnam Veteran memorials.
