- The Waterfront Section 106 meeting was offered online and in-person.
- Three Commissioners are doing the best they can to protect archaeological resources.
- Archaeology Summer Camp for teens will be wrapping up on June 27. Between 3 and 3:45 p.m., the students will be holding a final presentation and describing their excavation square.
- On June 21 a Juneteenth event will be held at Douglass Cemetery.
- AAC will be touring Ivy Hill Cemetery at 6:30 p.m. on June 18 to learn about their experience in obtaining a National Historical Place designation.
- Archaeology staff participated in the New York State Museum installation of the ship discovered under the World Trade Center. The museum is building a cradle for its hull.
- The AAC received the Commission of the Year Award, which will be received at the June 24 Council Meeting.

Old Business:

- Summer Meeting Schedule A motion was made by John Patrick and seconded by Roberta Stevens to take the August HARC meeting off the schedule this year. The motion carried.
- Waterfront Pump Station Members of the Archaeology staff and Archaeology Commission attended the Section 106 presentation.

Standing Committee Reports:

Alexandria Community Remembrance Project (ACRP) – Nigel Mease

- Attended the first meeting on June 11 at the Alexandria Black History Museum. The
 discussion included sponsorship for the Remembrance Students Club at Alexandria City
 High School to participate in three days of immersive learning about Alexandria's
 African American community history.
- The August 8th Remembrance of Benjamin Thomas is being planned and will be held at Shiloh Baptist Church with special guest speaker Steven Hahn (historian and Pulitzer Prize winner) at 6:30 p.m.
- A Faith Leaders affirmation statement was presented to the City Council on June 14.

City Hall and Market Square Redesign – John Patrick, Gail Rothrock

• Four concerns about the current design were discussed, specifically, 1) the amount of glass on the walls of the new 5th floor structure that can still be seen above the Victorian northern roof line from the intersection of Cameron and North Royal Streets and possibly also from the intersection of Cameron and North Fairfax Streets; 2) the plainness and lack of visible support for the proposed masonry-clad beams that seem to hover incongruently

above the ground-floor arcade on the 1963 Market Square elevation; 3) the proposal to light the glass hyphens at each end of the 1963 insert from the inside to illuminate the newly exposed walls of the Victorian Structure, but which will instead draw attention to the incongruent metal staircases within the building; and 4) the size of the viewing terrace on the roof. John Patrick said that skylights could provide an alternative to glass walls for lighting the northern portions of the proposed 5th floor structure's interior. He also said that it would be more visually plausible to make the supports for the beam above the south arcade clearly visible and clad them in the same material, and that exterior lighting of the Victorian walls would be more effective than attempting to light them from the interior of the glass hyphens.

• John offered to present the first three of the concerns listed above to the June 18 BAR meeting on behalf of HARC, along with his suggested solution for each concern. aA motion was made by Gail Rothrock and seconded by John Patrick to authorize John to make that presentation. The motion carried.

Board of Architectural Review (BAR) Update: Bill Conkey

Design Guidelines

• The BAR Design Guidelines Committee met last week to continue the update to the 1993 Design Guidelines. As Bill previously mentioned, the committee has been focusing on updating chapters for the Parker Gray District. Now that a significant batch of those chapters is done, they are ready to apply those to the Old and Historic Alexandria District (OHAD). The first batch of new OHAD Guidelines will be taken to the Board in July.

Waterfront Park

• At the last BAR hearing, the Board heard a Concept Review for the design of Waterfront Park, the Pump Station, and the pedestrianization of the first two blocks of King Street. Board members generally supported the design for Waterfront Park and for King Street with some minor comments. There was significant discussion regarding the design for the Pump Station with Board Members providing feedback on the proposed design and location.

910 King Street

• The renovation of the building at 910 King Street returns to the Board for their review tomorrow evening. The renovation includes modifications to the building and the construction of a roof deck. The Board made significant comments regarding the proposed design at the previous hearing and the applicant requested a deferral from the Board to address these concerns. The revised design addresses some of these comments but there are others which remain unresolved.

Office of Historic Alexandria (OHA) Report: Gretchen Bulova

Historic Alexandria's TOP 10 Accomplishments of FY2025 (July 1, 2024 – June 30, 2025)

- Received the 2025 Preservation Virginia Award for the exterior restoration of the Murray-Dick-Fawcett House (517 Prince Street).
- Nearing completion of the exterior renovation of the Freedom House Museum, including the rehabilitation of the front façade to its pre-1861 appearance. This project was fully

- funded through grants and donations. Oak Grove Construction began the project in June 2024 and the work will be completed in July 2025.
- Completed the Comprehensive Plan for the Murray-Dick-Fawcett House in partnership with Glave & Holmes Architecture. This plan will serve as the road map for the conversion of the site from a residence to a museum once the life tenancy for Joe Reeder concludes. The plan was funded through donations.
- Established a separate 501(c) (3) foundation to support OHA the Foundation for Alexandria History and Museums, Inc.
- As part of the America250 and VA250 initiatives, commemorated the 250th anniversary of the signing of the Fairfax Resolves was celebrated with more than 400 people in attendance. Collaboration partners included George Mason's Gunston Hall, George Washington's Mount Vernon, NOVA Parks, and the Sons of the Revolution (Fairfax Resolves Chapter). Additional collaborations of the commemoration included a "Road to Revolution" interpretive marker, a souvenir pocket-size Fairfax Resolves, a lecture at Gunston Hall, and a symposium at Mount Vernon.
- Commemorated the 200th anniversary of the marquis de Lafayette's Grand Tour in 1824/1825 with events at the Lafayette House and Gadsby's Tavern Museum, walking tours, a lecture filmed by CSPAN, and a commemorative interpretive marker.
- Commemorated the 10th anniversary of the dedication of the Contraband and Freedmen Cemetery, in collaboration with a descendant committee. The three-day event included tours of Alexandria African American churches, a luncheon with a keynote speaker, oral history story circles, and a candlelit vigil at the cemetery.
- Published the *Alexandria Historical Sign Finder: History around the City* on the City's website to help residents, researchers, and City staff easily locate historic makers throughout the City of Alexandria. This interactive map was designed in partnership with the City's GIS Department.
- Highlighted and ensured the proper documentation of the Alexandria Canal at 901 N. Pitt Street. Worked closely with DPI, TES, and the developer to salvage and store the canal structural stones for future use in Waterfront Park and future flood mitigation infrastructure. More than 500 residents and visitors attended the snowy January public viewing day of the excavated canal.
- Initiated a regular Historic Alexandria social media video series to showcase Alexandria's history and expand OHA's interpretation and reach.

• Robert Ray introduced himself. He is the Chair of the Alexandria Public Library Board and is on the boards of the Old Town Civic Association and the Alexandria Association.
