St. Martin de Porres Senior Center COVID-19 Report January 2021

During the month of December and the senior center's second month for reopening we noted our attendance began to slowly increase as seniors were comfortable returning and to see there friends again. It was great to see how everyone abided by safe COVID-19 practices facial covering, physical distancing, hand hygiene and remaining home when ill. Our average daily census for the month was 18. Most seniors signed up for two days a week and some requested to come an extra day during the week. Our popular days were Tuesday where we offered two ESOL classes for beginners and intermediate speakers. It was great to see everyone enjoying themselves and staying COVID free. Our focus continues to keep safety front and center adhering to COVID-19 health screening practices. Our activities were primarily in person with some hybrid activities in the afternoon for those who are home or would like to participate virtually.

- The following activities and wellness checks continue:
- We continue to do outreach/wellness calls for the seniors meeting basic needs delivering supplies as needed to seniors home bound. The seniors report doing well and are hopeful for reopening.
- Food and Fun with Chef Philippe
- 46 Activity Kits with trivia, puzzles, crossword puzzles, crafts, sudoku and fav holiday recipes
- Continued partnership with Patrick Henry Recreation Center (PHRC) for senior Pop-Up exercise and arts and crafts
- Intergenerational activities were fun with 10 Hayfield High School students and the seniors
- We registered 15 seniors for their COVID-19 booster vaccine at the PHRC. We continue assisting seniors get their booster and answer questions.
- Virtual programs such as robust Zumba, Line Dancing, and Zoom SAIL exercise classes.
- Senior Shopping Trips: This month the seniors participated in weekly shopping trips. Seniors requested weekly trips to Walmart and Family Dollar Store, and Landmark Plaza.
- The combined Holiday and birthday celebration was led by the St Jude Children's choir
- Senior capacity limited to 20 seniors per day. Average Daily Census was 18.
- Due to rising positivity rate of 16 and the increase of Omicron in the local area, the Alexandria Health Department advised us to temporarily close for the month of January. SMdP is closely aligned with ALX Promise Gold protecting our community and seniors during COVID-19.
- All meals from Jeffrey's Catering service went well. Seniors enjoyed a delicious holiday turkey meal and all the fixings.
- DAAS Bus transportation is going well averaging 4-10 riders. Others walk here from their homes

The Senior Center at Charles Houston December 2021 Report for January 2022 Meeting

Staff continue to provide weekly wellness telephone checks, weekly teleconference & Zoom virtual activities. Virtual activities include Bingo and cognitive/brain teaser exercises (i.e., scavenger hunt, geography, general and television trivia, word search, word scramble and rebus puzzles). For the month of December, we added holiday themes to the brain teasers. SC@CH Staff also continue to coordinate with the other two senior sites (St. Martin's and ADSC) for possible combined virtual cognitive and physical activities.

Other notable activities and events during December include:

- Wellness/Informative Wednesday Presentation Chef Philippe conducted a cooking demonstration on how to prepare Kamala Harris' Cornbread Dressing;
- Weekly Thursday Shopping Trip Trips were provided to local area markets and grocery stores, including Walmart, Dollar Tree, and the Dutch Amish Market to enable participants to purchase food, medical supplies, and essential household items;
- Weekly Monday Walking Cub Participants enjoy a weekly walk at Belle Haven Park to stay active and fit. The Center has a monthly average of 9 participants that consistently participate in the walking club;
- Arthritis Exercise Class Participants enjoy a virtual exercise class over Zoom twice during the month. The Center has a monthly average of 13 duplicated participants in the exercise class; and
- Goody Bag Distribution SC@CH Staff put together goody bags with special treats and holiday gift cards for each participant. The goody bags also contained PPE (masks, gloves, and sanitizer) for everyone. Staff continue to encourage seniors to wear masks, practice good hand washing, and utilize other mitigation measures to keep themselves safe during the pandemic.

Lastly, our seniors were able to have some festive fun by attending a Holiday Dinner/Dance party with the Departmental Club and Mt. Vernon Recreation Center. In addition to snacking on holiday goodies, the seniors were not shy to show off their dance moves.

Our seniors continue to be in high spirits despite the ongoing pandemic. Their daily needs seem to be met and if a situation arises that they are unable to handle, SC@CH Staff direct and oftentimes guide them to the correct service provider/resource.

Snow Buddy is a Volunteer Alexandria program which provides snow removal and sidewalk treatment for eligible Alexandrians. Volunteers are matched with low-income seniors or homebound or disabled residents who are physically unable to do it themselves, cannot afford to pay for this service, and/or do not have neighbors, family, or friends to assist them. Eligible applicants need to verify that they are homebound, disabled, and/or sixty years old or older, and that the total household income is at or below \$48,508. Review and Approval of the Agenda — A motion was made and seconded to approve the agenda (previously provided by the Chair). Note: At the meeting start, we did not have the requisite number of members to approve the agenda, so the item was tabled. Once we had the minimum essential number of members on the Zoom call, the agenda was approved.

Discussion

- 1. The Chair gave a brief review of what occurred at the most recent Alexandria Families for Safe Streets (AFSS) meeting (the Chair and Charles Bailey attended). Most of the AFSS meeting centered around discussion of the "Near Miss" data being recorded via the group's Dashboard. The group is doing analyses to see if any correlations can be identified between the reporting of "near misses" and actual accidents in related areas. There was a comment that Dashboard information appeared to show that "Near Miss" reporting is trending up. There was also a discussion that there may be value in looking at the time of day that data is recorded (perhaps a need/desire to adjust the data graphs).
- 2. A major item on the agenda was to discuss evaluation requirements for the AARP Alexandria Age Friendly Plan, which are being worked on by Jane King and Michael Schuster. Neither Jane or Michael were not present and the discussion on the topic was tabled.
- 3. The Chair indicated that the Alexandria Bicycle and Pedestrian Advisory Committee (BPAC) was in the process of identifying a new Chair and that efforts to contact them for information on their next meeting have not been effective. In the last TCom meeting, Bill Campbell had volunteered to be the liaison to BPAC, and he indicated that he's not had any contact with anyone in the group. Ray and Bill will work together to identify good contacts and get information on the next BPAC meeting.
- 4. There were two general comments. One concerned the need for us to reach out to the DASH folks to help them ensure that information is being dispersed as widely as possible to current and potential ridership. Another concerned looking into possible improvements to the intersection of Mt. Vernon Avenue and West Glebe Road. Charles said he would contact Mike Doyle (AFSS). Mike Doyle was interviewed on the local news and his group is very concerned about that intersection.

<u>Livable Community Plan</u> Jane King is preparing final report for AARP and will work with Committee Chairs to develop plans for the next three-year plan.
