# Adult Day Services Center Report to the Commission on Aging March 2021

As you all are aware, the ongoing pandemic has severely impacted the mental, social and emotional well-being of older adults, especially in long term care facilities. It has also impacted the adult day center community as well.

Since temporarily closing our doors in March of 2020, some of ADSC seniors have expressed experiencing feelings of loneliness due to not attending the center and not being able to physically socialize with peers and staff. The impact of the pandemic has also shown a physical decline, an increase in hospital visits and rehabilitation referrals for some of our higher risk seniors.

The pandemic has not only impacted our participants, but our caregivers and their families as well. Some of the consequences of COVID-19 for caregivers have been;

- Loss of jobs
- Had to move out of state to be near family to get help caring for their loved ones.
- Difficulty of caregiving without day support
- Needed respite
- Emotional toll of being overwhelmed

We know it's been a long tough year but we are all in this together. ADSC is committed to providing resources, suggestions, activities and being there for our participants and their families.

Alexandria Housing Affordability Advisory Committee Report

Due to the Coronovirus pandemic today's AHAAC meeting was held with ZOOM.

- 1. Chairwoman Michelle Krocker opened the meeting promptly at 6:30 PM.
- 2. The Landmark Mall Redevelopment Process was reported on by Ashley Labadie

Applicant's planning is built on previous work done in 2018 - 2019. There have been four meetings and public hearings. The proposal to date shows a maximum of 4.2 million square feet in density. A new INOVA hospital is planned to be 1 million square feet, approximately. The maximum number of housing units will be 2,500. Housing will include affordable, multi-family, townhouses, and housing for seniors. 20% of the development will be non-residential. A fire station is to be built with affordable housing attached. There will be a new Transit hub, and 3.5 acres of ground level open space. The housing plan is to support people working at landmark with incomes for 30 to 80% of ami.

In he Q&A it was mentioned that the greatest housing need is for low-income seniors to have an affordable assisted living facility, as there is currently none in Alexandria.

3. An update of the Arlandria-Chirilagua project was given by Jose Ayala and Tamara Jovovic.

Plans are being made to upgrade this depressed area in the north part of the City next to four Mile run. Plans include developing new affordable housing and preserving existing market rate affordable housing. Amenities and support services needed by the residents of this area are also planned for.

4. ARHA was reported on by Carter Fleming, Commissioner.

The Ramsey property is still having problems getting certificates of occupancy. They hope they will have C of O's for all units in the facility by the end of April. Most of the residents of Ladrey have been vaccinated for covid-19. ARHA staff is going to their other properties to encourage residents to get vaccinated.

5. Jonathan Frederick, Executive Director, reported on AHDC.

Their DelRay product project is going along well. The new project planned for seminary road will have 31 townhouses, 6 two bedroom units, and 4 bedroom units. All will be home ownership.

# St. Martin de Porres Senior Center COVID-19 Report for April 2021

Senior Wellness Checks and Assistance for Participants -we continue to outreach to all our seniors and members from the community fielding calls and questions. Weekly telephone calls to seniors to assist with the following services:

- Registered two seniors for DAAS Frozen Meals on Wheels seniors who recently returned to area.
- Weekly shopping trips to Lidl, Landmark Plaza, Walmart and Springfield Mall for seniors
- Spring activity kits, senior requests for perishable food such as milk, bread, and oatmeal

COVID-19 Vaccinations for SMdP Seniors 75+: We continued to collaborate with Alexandria Health Department and family of seniors who are still awaiting vaccine appointments. Coordinated with Senior Taxi to schedule one senior for the second COVID-19 vaccine transportation.

Social Isolation: continue virtual programs for the seniors in Alexandria DAAS community to include weekly virtual classes with AADS and CHSC. Exercise classes are popular as well as ESOL classes. Weekly wellness check calls, trivia, exercise, musicals, current events, and humor.

Senior Shopping Trips: This month the seniors participated in 4 weekly shopping trips. Our trips include going Target, Walmart, Lidl, and Landmark Plaza.

Monthly Senior Newsletters: Mailed monthly newsletters to seniors with community and center updates, recipes, Coronavirus Q&A, and birthday greetings.

Weekly Virtual Newsletter: Emailed 30 newsletters to seniors and their family's information pertaining relevant information from SSA and the community to keep them informed in activities around the city.

Virtual Programming: SMdP seniors continue to participate with Adult Day Services Center (ADSC) virtual programs along with Charles Houston Senior Center participants. We continue to team up with other senior programs in the city and participated in various senior activities virtual and in place. We will resume our Arthritis Exercise class bi-monthly starting Tuesday, April 6<sup>th</sup> @ 10:00 a.m. We had a "trial run" this past Tuesday to ensure that our Zoom is working properly as well as ensuring our seniors are able to acclimate to Zoom. Our Arthritis Exercise instructor will continue to be Monique Bagby, we are very happy that she was able to join Tuesday's Zoom and that she's agreed to do the program virtually.

Our seniors still continue to receive their COVID vaccines through the efforts of Annie B. Rose, Ladrey and the City. Many have received their 2<sup>nd</sup> dose, most report little to no side effects.

As we have had some mild Mondays this month we resumed our Monday Walking Club @ Ben Brenman Park. Participation started a little slow but picked up on last week with a total of 11 seniors walking.

Overall, our seniors continue to be faring pretty well during the pandemic. Their personal needs are met, they have food, shelter and resources to assist them. If a need arises that they're unable to address, center staff provides assistance in directing them to the appropriate resources and referrals.

# Commission on Aging Housing Committee Meeting of March 15, 2021 Via Zoom <u>Draft Meeting Notes</u>

#### Attendance:

**Welcome** – Michael Schuster opened the meeting and welcomed participants.

**Review and Approval of the Agenda** – The agenda was approved as submitted (no vote required).

**Approval of Minutes** – The notes from February 22 were approved as submitted (no vote required).

**Age Friendly Community Plan** – Jane King reiterated the list from the February 22 committee meeting:

- Planning for a Mixed Income Affordable Assisted Living Facility encourage, facilitate, and plan for a dedicated facility with various public and private partners.
- Public education regarding home modifications to increase accessibility. This could include publicity about and presentation of AARP's Home Fit program.
- Increase funding for the Rent Relief program, as the Commission proposed two years ago.
- Educate about and advocate for more affordable housing for older residents, but with a better description of what the Commission means by affordable housing.
- Reduce the risk of homelessness among older residents, and the need for personal assistance with activities of daily living at homeless shelters (which is not currently available).
- Look at the NVAN platform for possible advocacy around real estate tax relief and assistance with homeowner association and condo fees.
- There needs to be an emphasis on racial equity in all goal areas.

Jane added several other possibilities:

- Develop publicity about accessory dwelling units
- Encourage home sharing and group homes
- Raise awareness of assistive living devices

Jan Macidull raised the issue of brick sidewalks, which have continued to appear at new developments outside of Old Town. Jane King and Michael Schuster will raise that issue with the Transportation Committee. Jan also suggested providing guidance to help residents of multi-family buildings obtain affordable personal care assistance from home care agencies by sharing aides. That suggestion will go to the Outreach and Advocacy Committee.

Michael asked Jane King to prepare her suggested priority list from among the above listed issue areas. That will be the focus of the April 19 committee meeting.

Terri Lynch suggested the possibility of the committee having a joint meeting with the Arlington COA's housing committee to share common goals and interests for the Age Friendly Plan. She will identify their committee chair for Michael to contact about a future meeting.

Helen Nelson raised a question about a homeless woman who died recently. She was concerned about mental health assistance for the woman. Terri Lynch suggested that the full COA might invite someone from the Community Services Board to address issues of mental health among the homeless and how the city tries to assist with them. Carol Layer can assist Babs with that contact for the fall.
