

St. Martin de Porres Senior Center COVID-19 Report for February 2021

Senior Wellness Checks and Assistance for Participants -we continue to outreach to all our seniors and the community at large. Weekly telephone calls to seniors to assist with the following services:

- Deliver weekly surplus DAAS Frozen Meals on Wheels seniors assigned to the center and COA.
- Weekly shopping trips to Lidl, Target, Landmark Plaza, and Walmart for seniors

COVID-19 Vaccinations for Seniors 75+: We are working with SSA, DAAS and Senior Taxi to schedule seniors for the COVID-19 vaccines. Currently, we assisted registering over 30 seniors 75+ for the vaccine and arranged Senior Taxi rides. Also, contacted seniors 65 and older to register for the COVID-19 vaccine and also answer questions. Many of our seniors want the vaccine

Social Isolation: increased enrollment on our bi-weekly virtual zoom class with 12 seniors. Chef Philippe emailed weekly recipes. Weekly "Zoom" calls for current events, trivia, exercise and humor.

Senior Shopping Trips: This month the seniors participated in 4 weekly shopping trips. Our trips include going Walmart, Landmark Plaza, and Lidl.

Due to inclement weather and fear of the increase in coronavirus cases seniors declined going on walking trips for the month and we will resume this Spring.

Monthly Senior Newsletters: Mailed 80 monthly newsletters to seniors with community and center updates, recipes, corona virus Q&A, and birthday greetings.

Weekly Virtual Newsletter: Email weekly 50 newsletters to seniors and their family's information pertaining relevant information from SSA, ADH they need and any requests. We appreciate all the families who actively ensure their parent participates

Virtual Programming: Seniors enjoy virtual programming and participated with the Alexandria Adult Day Services. We continue to collaborate with our other senior centers in the city. We are preparing to add a virtual ESL program in the near future.

Biweekly Zoom-ba (Zumba on Zoom) for our seniors twice a week continues to be popular especially as the outdoor weather is colder.

Commission for Women - At the January meeting of the ACFW, the Commission determined that its main focus areas for 2021 would be housing and supporting survivors of domestic and sexual violence. The Commission plans to form committees focused on each of these priority areas to identify specific opportunities for engagement. The committees will meet for the first time during the February meeting of the Commission. On January 27th, a number of members from the Commission participated in a virtual legislative advocacy day organized by the Virginia Sexual and Domestic Violence Action Alliance. Futher updates on the Commission's work will be shared as new developments arise.

Partnership for Healthier Alexandria - The Partnership for a Healthier Alexandria continues to work alongside the health department on preparing Alexandria's next Community Health Implementation Plan (CHIP). The current goal is to release the CHIP in February, and I will provide any further updates as soon as I receive them.

Commission on Aging Housing Committee Meeting of January 25, 2021 Via Zoom - Draft Meeting Notes

Attendance:

<u>Committee Members</u>: Michael Schuster, Chair; Charles Bailey, Bob Eiffert, Bill Harris, Marshall Hespe, Jane King, Denise Mackie-Smith and Babs Waters.

Staff: Terri Lynch, Division of Aging and Adult Services; Melodie Seau, Office of Housing.

Welcome – Michael Schuster opened the meeting and welcomed participants.

Review and Approval of the Agenda – The agenda was approved as submitted.

Approval of Minutes – The notes from December 21 were approved as submitted (no vote required).

Updates on the Age Friendly Community Plan:

Goal I – Accessory Dwelling Units – Michael Schuster reported on the City Council public hearing of January 23, 2021, where City Council debated and ultimately approved the new Accessory Dwelling Unit Ordinance. City Council voted to approve the ADU policy (6-1, with Councilmember Jackson voting no), with these changes:

- 1. A prohibition of exclusive short-term rentals (anything less than thirty days);
- 2. There will be an owner occupancy requirement at the time of construction of the ADU;
- 3. The zoning ordinance will say there is a permit fee (this will be addressed when the Council approves permit fees as part of the whole permit process);
- 4. Neighborhoods must be notified of new ADUs prior to their construction;
- 5. There will be a tier set back provision normally it would be 1-5 feet back, but if the structure is between 13.5 feet and less than 16 feet high, the set back is 2.5 feet; if the structure is between 16-20 feet, the setback will be 5 feet. Anything under 13.5 feet will depend on whether there are windows in the homes in the adjoining properties; and
- 6. After 18 months, staff must come back to the Council for an update and with recommendations for changes if need be.

Michael reported that Sam Shelby from Planning and Zoning estimated the cost of an ADU at between \$20,000 and \$400,000 dollars, depending on the type of unit constructed. Sam said the City does not expect there will be many ADUs to be built.

Michael reported that the changes above were the result of concerns raised by city residents. He said the Mayor and members of City Council were careful to address every issue. Parking came up a lot, but Mayor Wilson thought it best to leave it alone for now, because the time and cost of assessing the parking issue would not be productive.

Presentation – the City's Eviction Prevention Task Force – Melodie Seau, Director of the Landlord-Tenant Relations Division of the Office of Housing. Bob Eiffert introduced Melodie, with whom he worked in the early 2000's. He said she is an expert on landlord-tenant law in Virginia and is a member of the Task Force.

Melodie read from a presentation on the Task Force prepared by Kate Garvey, Director of the City's Department of Community and Human Services (the presentation was distributed

separately). The presentation details the participants in the Task Force and the numbers of persons assisted with rent payments in the city. Melodie noted that the program has been highly successful, with most of the major landlords in the city participating. The program provided \$5 million in assistance by the end of 2020. As long as tenants are working with landlords or the Virginia Department of Housing and Community Development (DHCD), they are assisted with rent if their situation is precipitated by Covid-19. The assistance they receive is a grant, not a loan, and does not need to be repaid. In 2021, the state is now handling the program: tenants register with DHCD and landlords register with Virginia Housing (formerly the Virginia Housing Development Authority). Once a landlord has established the tenant's need and qualification for the program, landlords can submit invoices for overdue rent directly to Virginia Housing and receive reimbursement directly. It appears that the assistance will go on for as long as necessary, using state Housing Trust Funds. Melodie noted that if there are any other questions about the presentation or the program, committee members can contact her directly at melodie.seau@alexandriava.gov

Michael thanked Melodie for her presentation.

Other Business

- Charles Bailey reported that the Alexandria Redevelopment and Housing Authority (ARHA) has received approval for their application to change the funding designation for the Ladrey Senior Highrise from public housing to Housing Choice Vouchers. This change provides ARHA with nearly double the funding per unit and will allow ARHA to rehab or replace the building over time. Bill Harris has been working with Helen McIlvaine, the Director of the Office of Housing and Keith Pettigrew, the Executive Director of ARHA to explore the possibility of using Ladrey as an affordable assisted living facility. Such a facility would benefit all ARHA's older residents who need a greater level of assistance and could also benefit residents of other senior facilities who need assisted living. The ARHA board will discuss the possibility at its meeting on January 25.
- Charles also reported that the Alexandria Health Department used Ladrey as a Covid-19 vaccination site so that all residents could be vaccinated.
- Terri Lynch reported on the annual usage of the City's Tax and Rent Relief programs:
 - The Residential Real Estate Tax Relief program assisted 784 older households and 24 disabled households in 2020; and
 - o The Rent Relief program assisted 82 households in 2020.
- Jane King announced that the Commission on Aging and its committees need to update the Age Friendly Community Plan for 2022 through 2024. The Housing Committee has essentially completed its 2019 through 2021 goals, except for the affordable assisted living goal, which is still in progress and will be carried over in the new plan. The plan will need to be approved by City Council and sent to AARP for approval by December 2021.

1. Approval of Agenda

The agenda was approved as proposed.

2. Updates on Outreach to:

Faith Community: No update.

<u>LGBTQ</u> community: Ray will continue to participate in the activities of the task force, which is planning activities for Pride Month in June. Last year's Pride webinar was conducted on ZOOM and had a very large audience. Issues for seniors was one of the topics discussed.

<u>Senior Ambassadors</u>: MaryAnne reported that six more were trained recently, bringing the total of Senior Ambassadors to about ninety. Ambassadors continue to effectively engage in outreach activities in the communities they serve.

3. Continued Discussion on Outreach via Civic Groups

A complete list prepared by Gary was distributed by Victoria prior to the meeting. Gary explained that he found about 39 Civic Groups and a number of HOA and Condo Associations. He made in depth search on about 21 of them on their respective websites and Facebook pages, and finding up to date contact information is difficult. He suggested that we consider developing a relationship with the Community Policing

Section of the Alexandria Police Department as those officers serve as liaisons with civic and community organizations. We will check with SSA leadership to ensure we aren't duplicating efforts before moving forward to consult with the Commissions police liaison, Sgt. Ian Torrance.

Information was exchanged on the latest status of COVID 19 Vaccines, the challenges faced in faster distribution, and the hope that the new administration will address those challenges effectively.

Jane King suggested we develop an article for the Zebra about ADUs to dispel some of the misinformation about them that was aired at the hearing held prior to the Council's vote to approve them. We will work with the Housing Committee on this.

Babs Waters shared information about the work of 880 Cities, a non-profit organization that brings citizens together to enhance mobility and public space so that together we can create more vibrant, healthy, and equitable communities. She described innovative efforts in cities in Wisconsin, New York, and Colorado to ensure that outdoor spaces, such as biking/walking paths, were accessible for activities in the winter.

Review and Approval of the Agenda – The agenda was approved as submitted.

Discussion

<u>Complete Streets Program</u> - Ray spoke with Christine Mayeur (T&ES) about giving a presentation to the full Commission on the Complete Streets Program to include an update on Vision0 Safer Streets, possibly in March. We would plan to provide and receive questions ahead of the presentation to maximize the information shared. For example, Alan asked how the City's schedule for Complete Streets has been set back or impacted by the pandemic or other factors. Christine would also like feedback on some of their recent projects.

<u>Walkability Audits</u> - Jane talked to Christine Mayeur about the CoA doing Walkability Audits in the spring, possibly places on Duke Street that will be affected by the planned transitway. Jane shared that we use walk audits to identify issues for the City to address. This was echoed by Jim Durham and he also noted that doing walk audits could help us be more aware of what corrective actions might be needed in other parts of the city.

BPAC keeps spreadsheets of issues they've identified to the City so they can track progress with T&ES. Jim suggested walk audits include the intersection near Duke St/Taylor Run/Telegraph Rd and that BPAC would be willing to participate in the audits. Alan shared that there are parts that are confusing for pedestrians and have limited pedestrian access to cross Duke St.

There might be major changes with the Duke St. transitway from around Landmark to Telegraph Rd. The City plans to start public meetings next year. For more information see

<u>Pedestrian Education</u> - Alan noted that while AARP has a good driver education program, and provides very good guidelines for walk audits, they don't have a pedestrian education program. Alan found a detailed pedestrian safety program on the National Highway Traffic Safety Administration (NHTSA) website.

Jim said BPAC could partner with us in doing workshops. They currently do bike & pedestrian safety workshops for students. BPAC has asked the police to monitor crosswalks because too many drivers don't stop; educating drivers is a more important goal than simply writing tickets. Ray observed that these education programs need to happen on a regular basis in the future as people join and leave the area, and their driving/walking habits change. Jane suggested that we could use parts of the NHTSA information for articles in the local papers in addition to providing workshops.

<u>Transportation services</u> - Jane shared that the AARP's Public Policy Institute recently released a paper on "Modernizing Demand-Responsive Transportation for the Age of New Mobility". Demand-responsive services are transportation options that do not follow fixed routes or schedules; examples include dial-a-ride, Americans with Disabilities Act (ADA) complementary paratransit, taxis, app-based ride-hailing, ride sharing, car sharing, bike sharing, and other technology-enabled transportation. This might appear to be more applicable in rural areas, however, coordination of services might be improved in urban areas such as Alexandria.

Public Comment – Jim Durham (guest) shared information on BPAC activities related to the Transportation Goals of the Age Friendly Community Plan (see notes above).

<u>Senior Employment</u>: Goal is to help seniors find employment and to encourage businesses to hire Emilia Turcios advised that the second 50+ Cohort program will begin January 19.
