### St. Martin de Porres Senior Center COVID-19 Report November 2021

We closed out the month of October with a flurry of activities as we look forward to reopening and improve comfort measures. To prepare for the long awaited and anticipated senior center reopening. Our focus is a safe reopening adhering to COVID-19 health screening. The wellness checks continue, and we continue to do outreach for the seniors in meeting basic needs delivering vegetables/herbs from the garden and bread donations. The seniors report doing well and are hopeful for reopening. We handed out activity kits for homework and included recipes from volunteers, seniors and Chef Phillipe. Also, we continued to partner with Patrick Henry Recreation Center for the outdoor weekly senior Pop Up exercise and crafts classes as well as Walk and Fit at Ben Brenman park. These outdoor activities have been well received by the participants. We have also helped the seniors register for their COVID-19 booster vaccines especially now as many seniors received the Moderna vaccine. We will continue assisting seniors when we are open.

Senior Wellness Checks and Assistance for Participants during the month we -staff continues weekly outreach wellness telephone checks for our seniors fielding calls and questions. Overall, the seniors report they are doing well and the few we haven't heard from we contact family members and the DAAS. Also, we continued weekly telephone calls to assist with the following services:

- Weekly shopping trips
- Promoting and transporting weekly to the Walking Club at Ben Brenman Park
- Participating at Patrick Henry Recreation Center's Senior Pop Up exercise and crafts
- Autumn activity kits, food deliveries of oatmeal, bread, fruit, herbs, flowers and vegetables the garden
- Distributed acorn squash, zucchini, various peppers and eggplant. Continued weeding and watering the garden as well as distributing herbs.
- Virtual programs such as robust Zumba, AFE classes, and Zoom SAIL exercise.

Senior Shopping Trips: This month the seniors participated in weekly shopping trips. Seniors requested weekly trips to Walmart and Family Dollar Store, LA Mart and Landmark Plaza.

Senior Newsletters: Mailed 80 monthly newsletters to seniors with community and center updates, recipes, Coronavirus Q&A, and birthday greetings.

Weekly Virtual Newsletter: Emailed 80 weekly newsletters to seniors/their family's information pertaining relevant information from SSA and the community to keep them informed of happenings around the city and educational programs online.

Virtual Programming: SMdP seniors continue to participate in Alexandria's Adult Day Services Center (ADSC) virtual programing along with Charles Houston Senior Center participants in their AFE exercise classes. Everyone enjoys the fellowship with other senior programs in the city.

### The Senior Center at Charles Houston October 2021 Report for November 2021 Meeting

Staff continue to provide weekly wellness telephone checks, weekly teleconference & Zoom virtual activities. Virtual activities include Bingo and cognitive/brain teaser exercises (i.e. scavenger hunt, geography, general and television trivia, word search, word scramble and rebus puzzles). Our Wednesday and weekly schedule have been revised to include virtual wellness/informative presentations such as cooking demonstrations, osteoarthritis treatment and COVID booster information. Houston staff continue to coordinate with the other two senior sites (St. Martin's and ADSC) for combined virtual cognitive and physical activities. Additionally, a weekly Thursday shopping trip to local area markets, grocery's, Walmart and Dollar Tree stores enable participants to purchase food, medical and household items is provided to our clients.

Our weekly Monday Walk Club @ Belle Haven park continues in "full swing mode" with an average number of 8 participants consistently walking, as well as twice monthly Zoom Arthritis Exercise classes remain steady with a monthly average of 13 duplicated participants.

During the month of October our seniors enjoyed a recent visit to a pumpkin patch and produce farm in Maryland (see attached photos), as well as a virtual cooking demonstration by Chef Philippe. In observance of Breast Cancer Awareness Month, a wellness presentation by Giant Pharmacist Arzu Moosvi.

Our seniors continue to do well in spite of the ongoing pandemic. Their daily needs seem to be met and if a situation arises that they're unable to handle, center staff direct and oftentimes guide them to the correct service provider/resource.

# Commission on Aging Housing Committee Meeting of October 18, 2021 Via Zoom <u>Draft Meeting Notes (10/18/2021)</u>

#### Attendance:

Welcome - Michael Schuster opened the meeting and participants introduced themselves.

**Review and Approval of the Agenda** – The agenda was approved as submitted (no vote required).

Review and Approval of the September 27, 2021 Meeting Minutes. The minutes were approved as presented (no vote was necessary).

### Updates:

- 1. Presentation on potential Senior Assisted Housing at the Old Power Plant.

  Jan Macidull gave a brief update on plans for developing the land comprising the old power plant in North Alexandria. She said that there are two parcels of land involved in the 18 acres of the older power plant. A portion of the land will be used by Pepco for power transmission purposes. Most of the land will be developed by a Chicago Developer, Hillco Properties, which is being represented by attorney Mary Katherine Gibbs. The development will occur in phases. Concept One was filed at the end of August. Jan said this is a good time to involve the CoA in promoting affordable assisted living on this site. According to Jan, the East and North portions of Old Town Alexandria have a high percentage of older persons, so this project presents an excellent opportunity for us to advocate for affordable housing options. At this point, the plans are general but will become more granular as the developer moves onto the later phases.
- 2. Proposed goals for new Age Friendly Plan Jane King and Lois Steele. The following changes were made in the draft goals: 1) in goal one, when the word "facility" appeared, it was made plural "facilities:" 2) in goal one, at the end of the action section, the following was added, "to include resources for funding"; 3) the third goal was revised to read, "Prevent the unnecessary or unwanted institutionalization of older adults who could and would prefer to remain in their homes or in the community for as long as possible"; 4) the objective under the third goal was rewritten to read, "Increase Alexandrians' awareness of available programs and services supportive of older adults and adults with disabilities as well as their caretakers"; 5. The first action under the third goal was rewritten to read, "Support public and private providers, and NORCs in their information and service outreach efforts to reach vulnerable adults and their caretakers; and to support budget proposals that would increase and expand funding for programs providing

personal assistance with activities of daily living." Lois suggested that the outcome for the third goal could be rewritten as, "There will be increased funding for services supportive to older adults and their caretakers including the funding of services that educate at risk older adults and assist them in accessing available support services to enable them to live in their homes and/or to find safe and secure living facilities."

Other Business – Jane King reported that she has had contact with the home sharing program, Silver Nest, and that there was no home sharing in Alexandria at this time. She agreed to recruit a speaker from the program for our next meeting.

**Adjournment** – the meeting adjourned at 2:15 p.m.

### 2) Walking and Biking Goal

- a) Identify combined total of walk audits conducted by COA, City staff, BPAC, and AFSS.
- b) COA members participated in bike rodeos organized by BPAC to teach children bike safety skills.
- c) Bicycle safety clinics and classes available to adults in Alexandria through the Washington Area Bicyclist Association.
- d) The state legislature changed the yield to pedestrians in crosswalks to require a full stop. COA members assisted BPAC in reviewing and updating signage at intersections.

### 3) **Transit Goal**

- a) Representation by COA on the ATV Stakeholder Group.
- b) Multiple briefings by DASH staff on development of ATV and implementation of the New DASH Network.
- c) COA member serves as chair of the board of directors that oversees the DASH Bus system.
- d) New DASH Network provides significant benefits to older adults, people of color, and low income communities with more frequent all day bus service serving these communities.
- e) Elimination of fares on DASH bus further improves equity and transit access.

Senior Consumers. No update.

<u>Senior Employment</u>. Goal is to help seniors find employment and to encourage businesses to hire. Emilia Turcios reported that the Workforce Development Center will be having new workshops for the 50+ community. November saw a higher volume, fizzled during summer, and anticipate an increase with the new workshops. Annabelle Reitman noted that she and Sylvia Benatti are still hopeful to participate in a resume workshop.

Emilia Turcios announced her departure. Salvador "Sal" Amado, WDC Partnership Manager, will be taking over.

Seniors as Entrepreneurs. Annabelle Reitman expressed continued frustration with the IRS. The three-year proposed budget was submitted with confirmation that it was received, but no further word. The advocate who she and Sylvia have been working with is optimistic, but until it's in writing, they can't proceed further. If no IRS response by Friday, Sylvia will call their advocate. In the meantime, they have their website pages planned out and are discussing launch plans. Jim Lindsay offered workspace. They might have assistance from a referral who has a master's in entrepreneurship.

<u>SNAP for Seniors</u>. Sandy Freedman reported that new SSA staff member, Margaret Shetler, has made several connections, including with Casa Chirilagua, DCHS, Neighborhood Health, WDC staff, to work together to coordinate outreach to the senior community to communicate recent SNAP benefits increase and encourage seniors to apply for benefits, or to reapply if they've previously applied but were denied benefits, given these new benefits increases.

Livable Community Plan. Jane King discussed a project sponsored by George Washington University and supported by a grant offered by AARP, the result of which will be a regional age-friendly network with the appropriate age-friendly planners' involvement. A conference is planned for October 27 to devise strategies for communities to use. Jane is representing Alexandria in planning for the October 27 meeting. Jane is preparing a 150-word overview of Alexandria's role on economic development and has found an earlier paragraph on WDC's role particularly helpful and asked Emilia Turcios to provide the number of training sessions that have been provided. Jane anticipates the conference to be interesting in the context of (1) recommendations from experts about community planning relevant to older adults, and (2) its intergenerational approach. GW students will be engaged.

Jane further noted that the City's Age-Friendly Plan expires in December and, while not necessarily needing to reinvent the wheel, anticipates a substantial re-write. She commended Councilmember Del Pepper's initiation of the WDC program.

<u>Public Comment</u>. Regular Committee guest Gerri Wallace reported that she submitted an application for a slot on Alexandria's Commission on Aging, and her application was rejected. She remains hopeful, and in the meantime, she's interested in being a Senior Ambassador.

The meeting was adjourned at 10:29 a.m.
