# Age Friendly Plan 2019-2021: Alexandria City

In June 2017, the City of Alexandria applied to and was accepted in the AARP/World Health Organization/AARP Network of Age-Friendly Communities. Alexandria was the first community in Virginia to be accepted in the Network, and the City thereby gained access to a national forum for the exchange of information and an abundance of ideas and programs. Alexandria then had two years to develop an Age-Friendly Plan. In 2012, the City had adopted a "Strategic Plan on Aging, 2013 – 2017, The Alexandria of Our Future: A Livable Community for All Ages". This Age-Friendly Plan is an excellent continuation of the work to advance Alexandria's accommodation of the needs of its older residents.

Planning for older residents encompasses the need of the entire community. What is good for older adults also benefits the young and everyone in between. Although its attention is directed to aging, the Age-Friendly Plan focuses on a livable community for all ages. The plan highlights activities in the following domains of livability: (1) social participation and respect and social inclusion; (2) housing; (3) transportation; (4) communications; (5) health and community services; and (6) civic participation and employment.

## Alexandria's Age Friendly Community Plan By COA Representative Bob Eiffert

The 21-member Alexandria Commission on Aging (COA) led the development of the City's Age Friendly Community Plan. During a 2-year planning process, AARP conducted a community survey of over 500 older Alexandrians to learn their concerns. The COA then held two community forums to assess concerns and priorities from among the survey responses and to ascertain any others. Using this data and the eight "domains" of an Age Friendly plan, the COA and its committees began to systematically address each of the domains and assign the appropriate community concerns to each. Using the Boston plan as a model, the committees prepared detailed action charts to address the needs identified. Commission members and others then drafted the text of the plan. When the draft was completed, the COA presented it to the City Manager, who assigned the various sections to the appropriate City departments for their review, and to align the plan with their individual plans and the City's master plan. The departments provided significant and substantive feedback that the COA incorporated into the plan. It then went to City Council for their approval and adoption of the plan in May 2018 for implementation beginning in 2019. AARP approved the plan in June 2018. The COA committees are now implementing the plan or working with other appropriate City departments and agencies and to assure that the plan is implemented. The plan is for a 3-year period that lasts through 2021, when the process will be repeated. The plan can be found at [add link].
