APPENDIX I
Results of Monitoring

RESULTS OF MONITORING

Archeological monitoring of excavation within the project area was required by the City of Alexandria under special use permit conditions for the development. The purpose of this monitoring was to locate and document any additional cultural features that may be considered significant. Monitoring was conducted in August 2007.

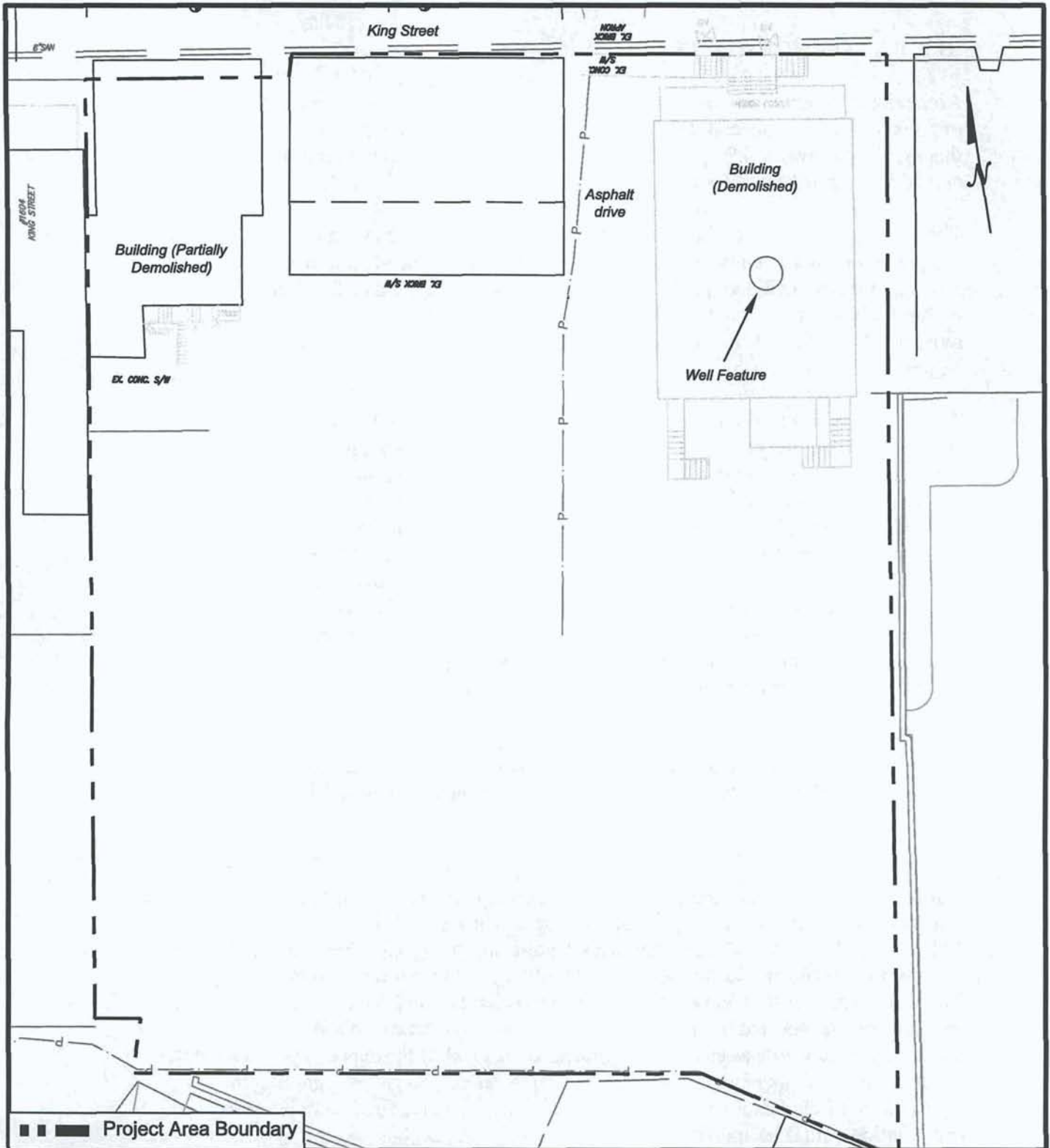
The entire project area, to the south of the existing buildings fronting King Street, was excavated in order to construct an underground parking garage (Exhibit 65). The project area was first divided into quadrants. Using a trackhoe with a five-foot bucket, the soils within each quadrant were to be evenly excavated in five foot increments. After the removal of five feet of soil across the entire project area, the next five feet of soil would be removed, and so forth.

The northeast quadrant was excavated first, approximately five feet below ground surface (Plate 105); next, the southeast quadrant was excavated slightly deeper to approximately seven feet below ground surface (Plate 106). A strip of land approximately 20 feet wide was left unexcavated between the northeast and southeast quadrants. The crew then worked westward along the southern property boundary taking the southwest quadrant down to approximately seven to eight feet below ground surface (Plate 107) and the strip of land between the northeast and southeast quadrants was removed. Finally, the first five feet of soil were removed from the northwest quadrant (Plate 108). Once the entire site had been excavated five to eight feet (Plate 109), the entire project area was then leveled by quadrants to approximately ten feet below ground surface. A small earthen ramp in the southwest corner of the property was left unexcavated for access into the property.

One feature, associated with site 44AX0202, was found near the base of the first excavation level, within the northeastern quadrant of the property and is discussed below.

Well Feature

During excavation of the first five feet of the northeastern portion of the property, a brick lined well was discovered at an elevation of approximately 13 feet above sea level (see Exhibit 65; Plate 110). The circular brick feature appears to have been located beneath the footprint of the previously demolished building and was filled with building debris. The well measured six feet in diameter and a wooden log pipe, possibly part of a pump mechanism, was located in the center (Plate 111). At the time of discovery, the area surrounding the well was cleared and graded to the level of the exposed portion and the construction crew was instructed not to disturb the area. Decisions regarding the significance of the feature and the level of documentation required were made in consultation with Alexandria Archaeology.

Methodology

The methodology used to excavate and document the well feature was determined by Alexandria Archaeology. The city archeologists requested that a small bisection of the well first be removed and screened for artifacts to determine the relative age of the fill deposits. Alexandria Archaeology required 100% recovery of any fill deposits that dated to the 19th century (the date of significance for the recorded archeological site on the property).

The well was hand excavated (with trowel and flat shovel) stratigraphically and all soil screened through 1/4-inch mesh hardware cloth screens. Deeper fill deposits were excavated in arbitrary 0.5 foot levels in order to maintain vertical control. Bisection wall profiles and plan views of the feature were photographed and drawn. Soil colors were described using the Munsell Soil Color Chart designations. Additionally, Alexandria Archaeology requested that any portions of the pump mechanism, including the bored wood log pipe, be drawn to scale.

Fill Deposits within Well Feature

The profile of the initial bisection showed eight fill horizons within the well (Plate 112, Exhibit 66).

- Fill 1: 0- 2.1 feet (0- 0.64 m) below surface- mixed 20th century fill horizons
- Fill 2: 2.1- 2.5 feet (0.64-0.76 m) below surface- [10YR 3/2] very dark graying brown sand
- Fill 3: 2.5- 3.0 feet (0.76- 0.91 m) below surface- [10YR 5/4] yellowish brown sand with quartz pebbles
- Fill 4: 3.0- 4.3 feet (0.91- 1.3 m) below surface- [10YR 3/2] very dark grayish brown sandy clay
- Fill 5: 4.3- 4.7 feet (1.3- 1.4 m) below surface- [2.5Y 6/4] light yellowish brown sandy clay
- Fill 6: 4.7- 5.0 feet (1.4- 1.5 m) below surface- [2.5Y 5/3] light olive brown wet sand with some clay
- Fill 7: 5.0- 5.8 feet (1.5- 1.8 m) below surface- [2.5Y 3/1] very dark gray wet sand
- Fill 8: 5.1- 5.6 feet (1.55- 1.7 m) below surface- [2.5Y 5/3] light olive brown wet sand with some clay

The uppermost four fill horizons extended roughly 4-5 feet below the surface of the feature and appeared to slope generally east to west. These levels all contained modern artifacts such as chunks of dry wall, PVC pipes, ceramic electrical insulators, and 20th century jar and bottle fragments). Fills 5 through 8 also generally sloped east to west in profile and extended to a total depth of 5.6 feet below the surface of the feature. Sterile subsoil was not reached at this time. Plates 113 and 114 show the initial excavation of the well. Although the final artifact processing revealed that the lowermost fills contained mixed 19th and 20th century artifacts, it was believed upon field examination that these fill horizons probably dated to the 19th century. Therefore, following

Alexandria Archaeology's scope of work, 100% of the lowermost fills were excavated and screened for artifacts. A complete artifact inventory is included as Appendix III.

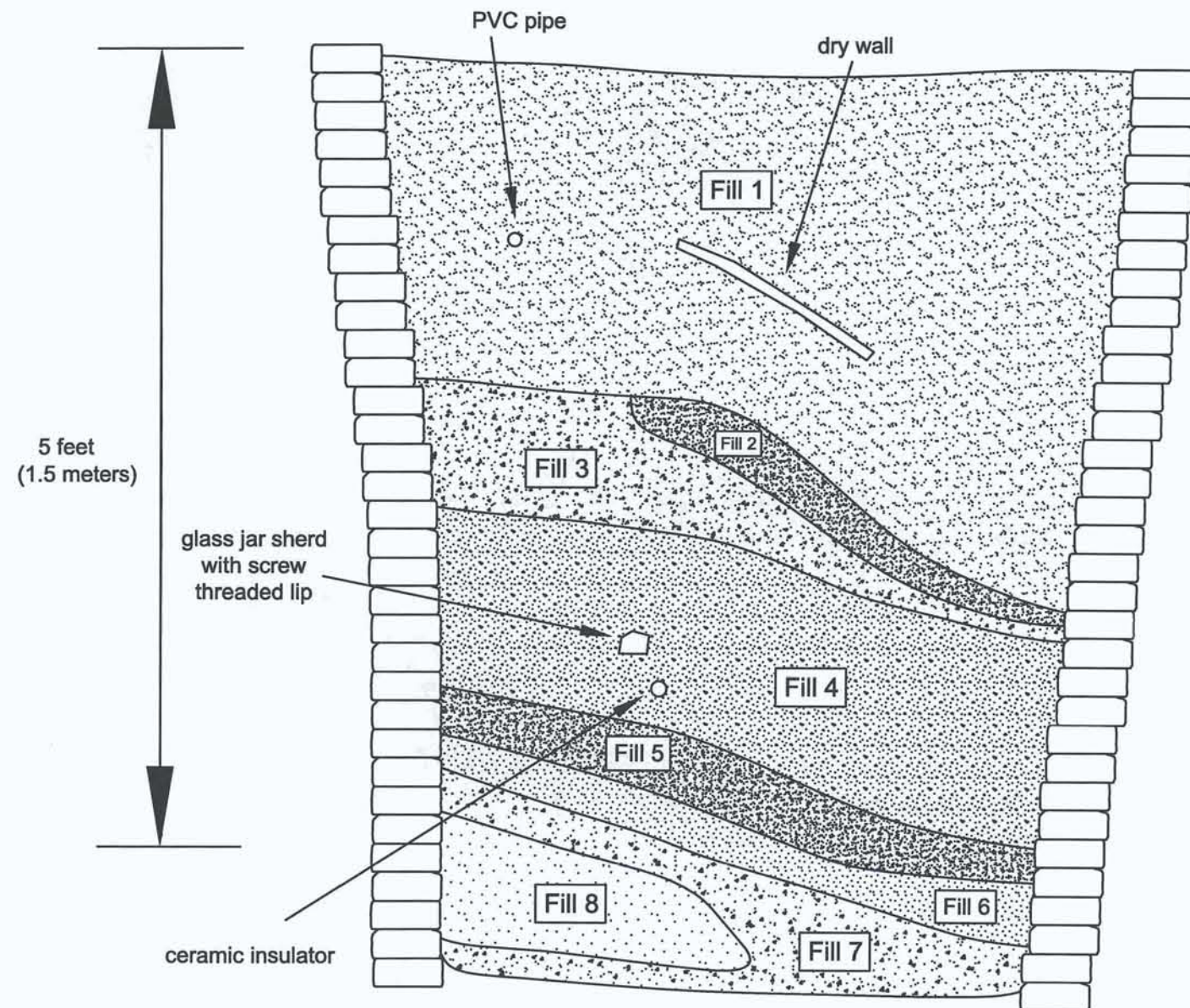
The well was bisected in half in order to determine the relation of the bored log pipe to the well. The profile of the second bisection showed five fill horizons overlying a thin layer of decaying wood, a thin layer of clay and natural C horizons (Plate 115; Exhibit 67):

- Fill 1: 0- 2.8 feet (0- 0.85 m) below surface- mixed 20th century fill horizons
- Fill 2: 3.0- 4.9 feet (0.85- 1.5 m) below surface- Alternating layers of [10YR 3/2] very dark grayish brown sand and [10YR 6/1] gray with [10YR 5/6] yellowish brown sandy clay
- Fill 3: 4.9- 5.4 feet (1.5- 1.6 m) below surface- [10YR 4/2] dark grayish brown sand mixed with plaster and brick fragments
- Fill 4: 5.4- 6.2 feet (1.6- 1.89 m) below surface- [10YR 5/2] grayish brown sandy clay with quartz pebbles and brick fragments
- Wood lens: 6.2- 6.25 (1.89- 1.91 m) – [2.5Y 2.5/1] black decaying wood
- Sand lens: 6.25- 6.3 (1.91- 1.92 m) – [10YR 6/1] gray sand
- Clay lens: 6.3- 6.35 (1.92- 1.94 m) – [2.5Y 5/3] light olive brown smooth clay loam
- C horizon: 6.35- 6.7 feet (1.94- 2.0 m) below surface- [10YR 5/2] grayish brown sand

The upper modern fill horizons (Fills 1 and 2) were removed using the trackhoe and discarded without screening (Plate 116). The remaining fill deposits (Fills 3-5) were hand excavated by quadrant (northeast and northwest) using 0.5 foot arbitrary levels and screened for artifacts. Fill 3 was only located on the eastern side of the profile, while Fill 5 was only found on the western side of the wood log pipe. Fill 5, a [10YR 4/1] dark gray sandy clay, was nearly one foot thick and directly overlay the wood lens. On the eastern side of the profile, the Fill 4 horizon overlay the wood lens. A very thin layer of decaying wood was found at the base of the profile overlying a thin sand lens. Beneath this, was a thin layer of clay overlaying sterile C horizons (Plates 117-119). Exhibits 68 and 69 show the lowermost soil horizons in detail.

Finally, the remaining southern half of the well was similarly excavated, although not by quadrant (Plates 120-121).

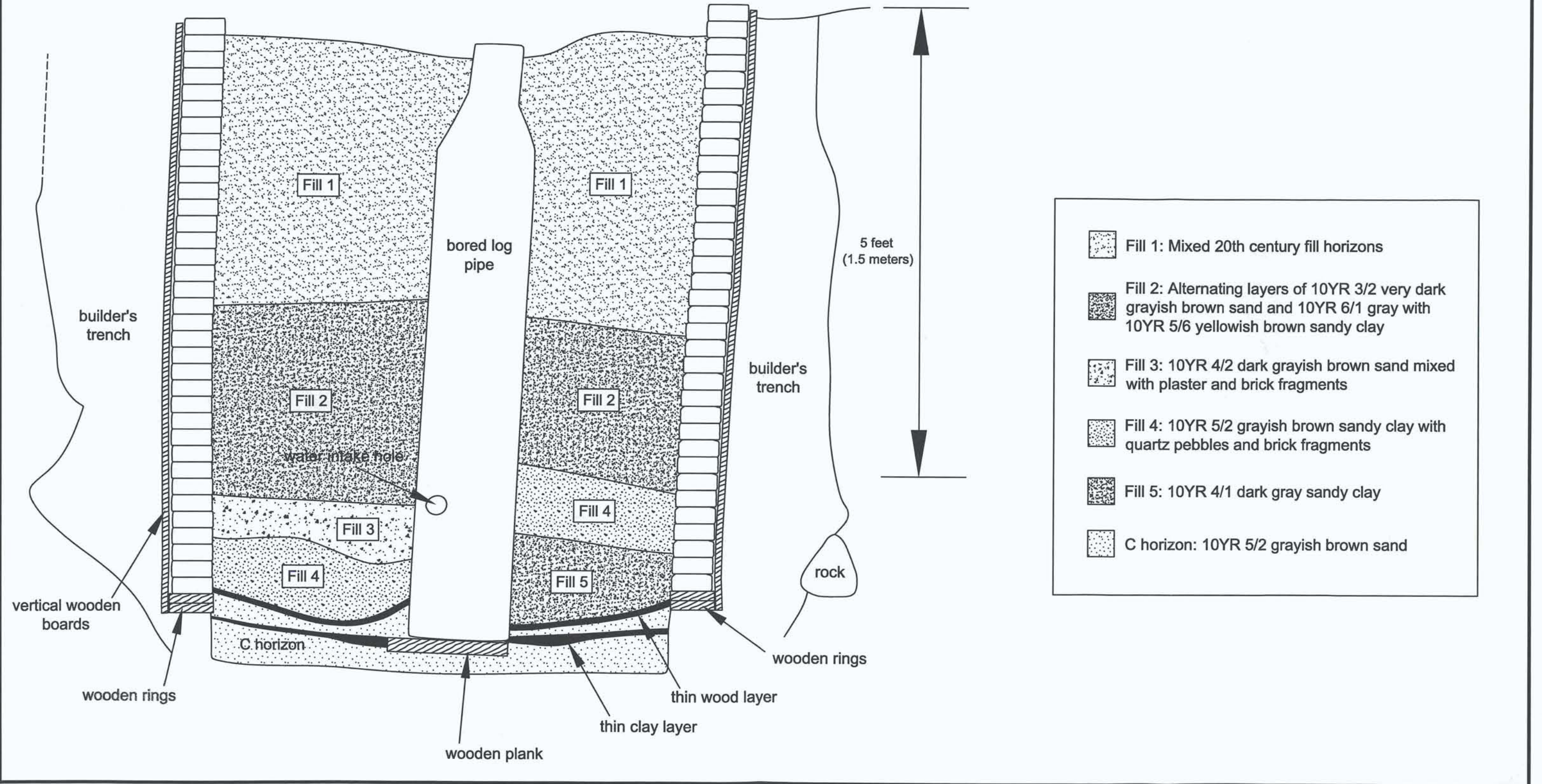
The builder's trench was clearly visible in profile (see Exhibit 67); in plan view, it encircled the feature unevenly, extending between 0.5- 1.5 feet away from the bricks. The trench was filled with a [2.5Y 6/2] light brownish gray sand and a [2.5Y 6/1] gray clay with [2.5Y 5/4] light olive brown mottling. An oyster shell was observed in the uppermost builder's trench fill; one stoneware sherd, one cut nail and brick fragments were recovered from the bisection at the base of the builder's trench. A plastic fragment was an obvious intrusion into this level and was discarded.

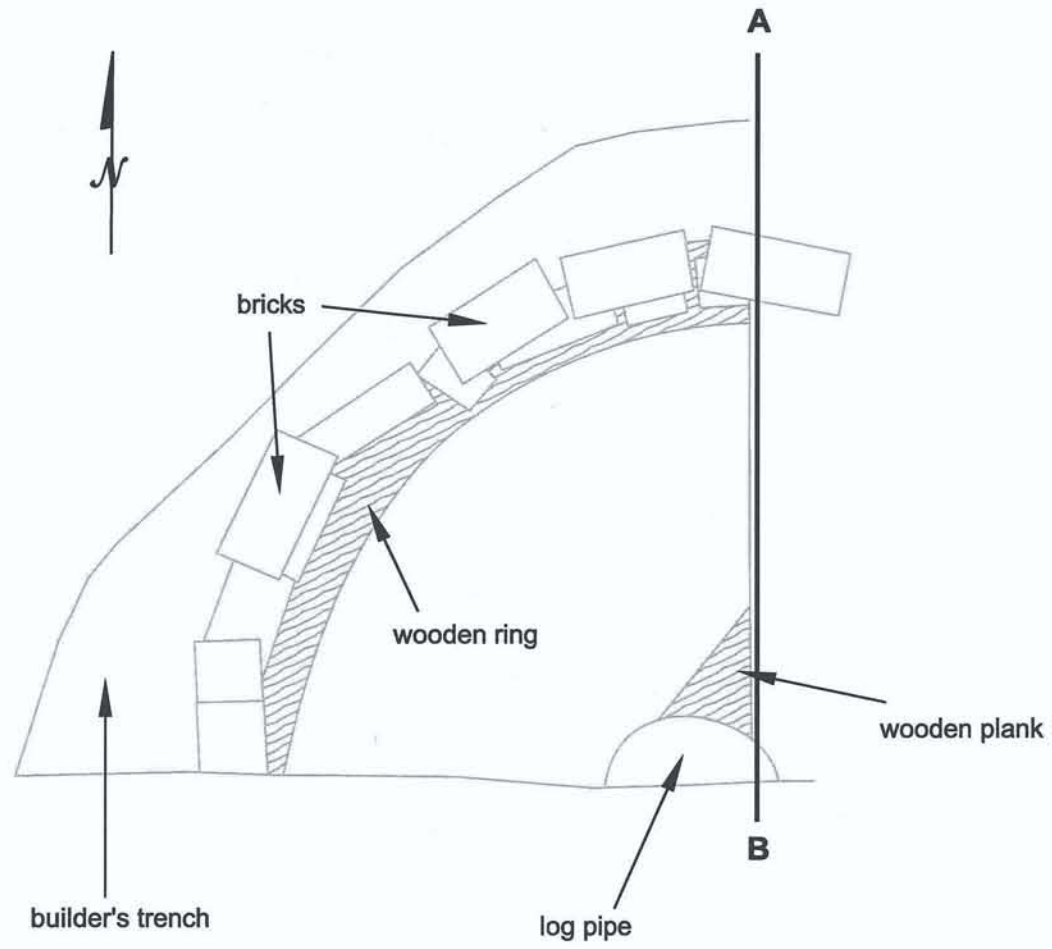

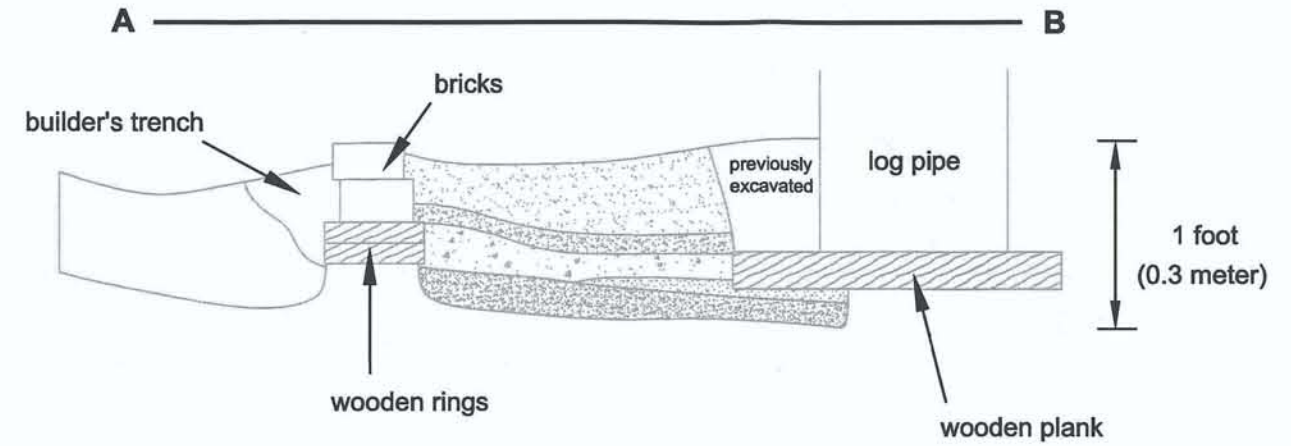


South Profile of the Second Bisection of Well Feature

Well Construction

The well measured approximately 6 feet in diameter on the outside of the bricks (5 feet on the inside) and was approximately 7 feet deep at the time of excavation. It appears that the upper portion of the well may have been removed during the discovery process; a portion of the wood log pump mechanism was located within the back dirt. The ground surface was most likely higher at the time of construction/use, and the well may have been at least 8 to 9 feet deep at one time.

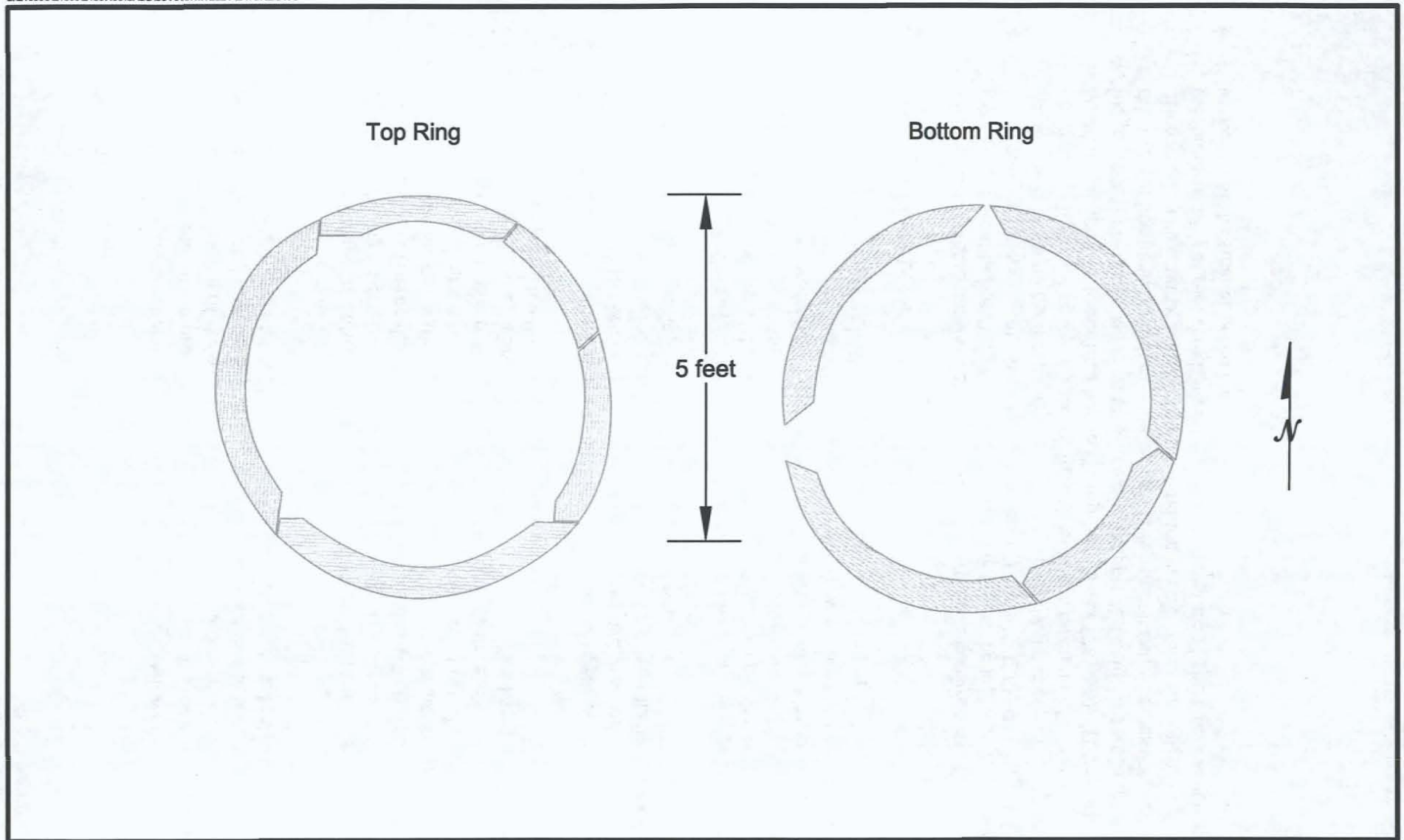
The well was constructed with stretcher bond dry laid bricks, which were resting within and supported by an exterior wooden frame, which surrounded the bricks. The wood frame consisted of vertical planks measuring approximately 6 to 10 inches wide and 1 inch thick running down the entire exterior of the well, that were nailed to two stacked wooden rings at the base of the well (Plate 122 and see Plate 119). The two stacked wooden rings were constructed of four to five rounded planks each, nailed together to form a circle (see Plate 122 and Exhibit 69). The courses of bricks were laid on top of the wooden ring, flush with the vertical planks.

The builder's trench surrounding the well was irregularly shaped, extending between 0.5-1.5 feet away from the bricks at the top and became narrower towards the bottom of the well. The trench was filled with a mixture of sand and clay, with the amount of clay content increasing significantly in the lower half of the feature.

The water appears to have been drawn through a bored wooden log pipe that was supported in the center of the well, which rested on a wooden plank (see Plate 115). The log pipe measured approximately 1 foot in diameter and was 6.5 feet in length. The wood plank at the base of the log pipe measure roughly 1.8 by 0.8 feet. A water intake hole had been drilled through the log approximately 1 foot above its base and the bottom of the log was plugged (Plates 123-124).

Log Pump Construction

The log pump which ran through the center of the well was constructed of a large bored log, another smaller bored log which attached to the top of the larger log, and presumably had a pumping mechanism which was not found (Plates 125-126). The large bored log was 6.2 feet long and had been cut to have eight relatively flat even sides, like an octagonal cylinder. The top 1.3 feet of the log had been tapered to fit inside the smaller bored log which likely was attached to the top (see Plates 125-126). The smaller wood log piece was also eight sided and was measured approximately 2.3 feet long. The top of this log had been damaged during the current construction activities, as the well was discovered. The original length of this second log is unknown. Although the pumping mechanism was not recovered, it was most likely a cast iron hand pump which attached to the top of the smaller bored log.

Summary and Conclusions

According to Alexandria City archeologist Steven Shephard, the well at the King Street property is similar in construction to other wells that have previously been discovered and excavated in Alexandria. A 1989 survey of historic wells in Alexandria found that 19% of the wells were lined with wooden planks and several contained wooden pumps (Shephard 1989). The excavation of this current well feature may offer a structural explanation for the wood planks found lining the wells discovered in Alexandria. It is theorized that the wooden frame was fully constructed above ground, and then lowered into the pit excavated for the well. This wooden frame may have provided protection against collapsing walls within the pit during the laying of brick, and would also serve as a guide for construction. This may have been necessary due to the extremely sandy soils on the property, which would easily collapse if not adequately supported.

Previous archeological work along the 1100 block of King Street resulted in the discovery of similar wood lined well shafts that were thought to date circa 1870-1907, primarily because of their location at the rear of the lot (Smith 1983, cf. Shephard 1989). The well found within the current project area is located at the rear of the house, not the lot, and appears to have been located under an addition, or in the basement of the building (see Exhibit 65). Although the exact construction date of this well is unknown, it likely dates to the 19th century and is included with Site 44AX0202. The well appears to have been abandoned by the late 19th early 20th century, around the time of the construction of the house located at 1514-1524 King Street. The large amount of modern structural debris in the upper four feet of the well appears to have originated from the demolition of the house, suggesting that the well was not entirely filled after abandonment, and may have been covered.

The well (and bored log pump) located during the archeological monitoring is supported by documentary evidence. Land tax records and an *Alexandria Gazette* newspaper advertisement in 1851 indicate that Home constructed a frame dwelling, a brick "negro jail," a cultivated garden, a *water pump*, and several outbuildings on the property. The *water pump* is likely this well.

Archeological monitoring at the King Street properties presented a unique opportunity to fully excavate a historic well from both the interior and exterior and has contributed to the knowledge base of well construction techniques within the city of Alexandria.

Introduction

The goal of this scope of work is to determine if significant archaeological resources are present within the project area. In the early 19th century, the project area was located adjacent to the Virginia Tavern; however, it is not until the mid 19th century that we find the first documentary evidence of buildings within the project area. In 1850, Lucien Peyton leased the parcels of land containing 1514-1524 King Street to Edward Home, a slave dealer. Home purchased the land in 1851 and land tax records for that year suggest that he made improvements to the property at this time. These improvements are described in an Alexandria Gazette advertisement when Home put the property up for sale later that year. The advertisement describes a "recently built" brick "negro jail," a frame dwelling, a cultivated garden, a water pump, and several outbuildings.

A Documentary Study has been completed for the property. This Scope of Work is for conducting the Archaeological Evaluation. The investigations will include the excavation of machine backhoe trenches to determine if archaeological resources are actually present. If significant features are encountered (excluding deep shaft features), this Scope of Work calls for their evaluation and if deemed necessary, excavation. If a significant site or sites are discovered as a result of the field work, the sites must be registered with the Virginia Department of Historic Resources.

All aspects of this investigation will adhere to OSHA regulations and will comply with the *City of Alexandria Archaeological Standards* dated January 1996 and the *Secretary of the Interior's Standards and Guidelines for Archaeology and Historic Preservation*. Miss Utility must be informed before excavations are made. All open excavation units will be fenced when no personnel are present.

Archaeological Testing

The archeological excavation plan consists of excavating exploratory backhoe trenches of varying length across the property to determine if intact buried ground surfaces and features are present. Locations of the trenches were established in consultation with Pam Cressey, Alexandria City archaeologist and take into account information gathered from the documentary study (Exhibit 1). The total number of trenches will not exceed eleven (11).

All trenches will be five feet in width and will be excavated with a machine backhoe outfitted with a smooth blade bucket. The purpose of these trenches will be to locate intact ground surfaces and features. At least one soil strata column profile will be drawn for every trench. Photographs will be taken. Trenches will be back filled after recordation of the soil profiles if features/buried surfaces are not located. In trenches where features occur, the excavations will be expanded if necessary to allow for safe hand excavation and evaluation.

If the event that features or pre-20th-century ground surfaces are encountered, additional work will be needed to access the significance of the findings. Decisions regarding the significance of features and the need for additional testing will be made in consultation with Alexandria Archaeology. The features discovered during this process will be drawn and photographed and if deemed necessary, excavated. The additional work may involve a combination of trench expansion and hand excavation of 5 x 5 foot square test units. The trench expansion may involve stripping of larger area to expose significant features. **The additional work will be billed to the client on a per test unit basis.** Refer to the Test Unit Excavations section below.

The cost proposal does not include the excavation of any "deep shaft" features, i.e. wells or privies, which may be encountered. Depending on the size and nature of these features, this may be added as an additional service.

Test Unit Excavations: If warranted, test units (5 x 5 feet) will be excavated as part of this scope to test potentially significant archaeological features and buried ground surfaces. The test units will be excavated stratigraphically and all soil will be screened through 1/4-inch mesh hardware cloth screens. Soil profiles will be made of representative units, with soil colors described using the Munsell Soil Color Chart designations. Artifacts will be bagged and labeled by unit number and by soil horizon. The work will be documented with field notes, sketch plans, photographs, and slides. Any features encountered will be mapped and made available for inspection by Alexandria Archaeology. **Since it is not known if the test units will be necessary, they will be budgeted on a per-unit basis.**

Archival Research: Archival and historic research will provide context for the archeological work by examining:

1. History of the Virginia House Tavern
2. History on the buying and selling of slaves by informal methods (through taverns and other places) in Alexandria.

Laboratory Work and Curation

Archaeological artifacts recovered from the project area will be cleaned, stabilized (if necessary), cataloged, labeled and packaged in accordance with the guidelines set forth in the *City of Alexandria Archaeological Standards*. Organic materials that may require conservation may be recovered; however, **the cost proposal will not include conservation services.** Conservation may be added as an additional service.

At the conclusion of the project, all original photographs, negatives, slides, digital images, videotapes, copies of historical documents, field notes and forms (original copy and a duplicate copy), other field records, as well as the artifacts if they are to be donated to the City, will be delivered to Alexandria Archaeology. Archaeological collections recovered as a result of the Alexandria Archaeology Resource Protection Code must be curated at a facility which meets Federal standards for archaeological curation and collections management as described by 36CFR Part 79. The Alexandria Archaeology Storage Facility meets these standards, and the property owner is encouraged to donate the artifact collection to the City for curation. The archaeological consultant is responsible for arranging for the donation of the artifacts with the owner and will deliver the artifacts and signed forms to the appropriate storage facility.

Archaeological Evaluation Report

The Archaeological Evaluation Report will include the following: a public summary; the results of the archival and documentary research, a map of the project area; a map with unit locations and significant features; a summary of the procedures; results of the field investigation and artifact analysis, including a distribution map or other graphics which indicate potentially significant archaeological areas; an integration of the field and analysis data with the historical record.

If the investigation results in the discovery of features that require additional archaeological work, the Archaeological Evaluation Report will include a Resource Management Plan. The Resource Management Plan will present a strategy, scope of work (including a map indicating locations of proposed work in relation to completed tests), and budget for further investigations. All archaeological sites discovered will be registered with the Virginia Department of Historic Resources and copies of the registration forms will be submitted to Alexandria Archaeology.

When the fieldwork is completed, one copy of the full Archaeological Evaluation Report will be submitted to Alexandria Archaeology as a draft for review. Once the report is approved by the City Archaeologist, revisions will be made, and four copies of it, one unbound with original graphics, will be submitted to Alexandria Archaeology. The report will also be submitted on a CD. All site maps and drawings must be inked or computer-generated so as to produce sharp and clear images that will result in clear photocopies or microfilms.

Public Interpretation

The *City of Alexandria Archaeological Standards* require that a public summary be prepared as part of an Archaeological Evaluation Report. The public summary will be approximately 4 to 8 pages long with a few color illustrations. 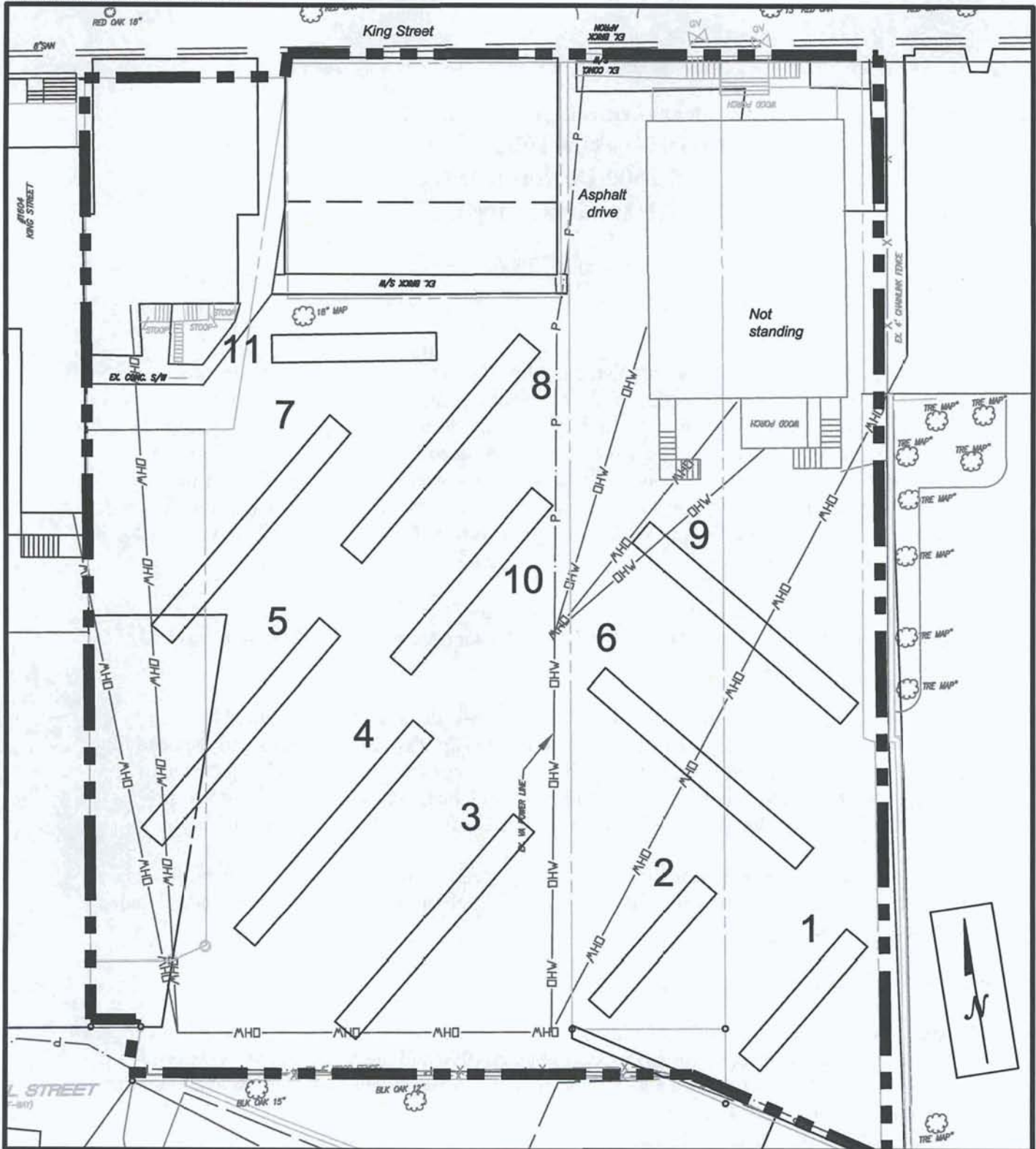

Scope of Work

Additional Archeological Investigations of 1514-1524; 1600-1602 King Street and 1602 Dechantel Street, Alexandria, Virginia

June 5, 2006

Introduction

Initial archeological investigations completed in May 2006 at the 0.61-acre parcel located between 1514 and 1602 King Street and at 1602 Dechantel Street in Alexandria, Virginia resulted in archeological evidence of the mid 19th century domestic occupation of the property. Although, the machine trenching revealed extensive and deep fill deposits across the project area, two 19th century features were located that have high research potential. The barrel well and pump (Feature 15) that was located in Trench 6 and the cobblestone feature (Feature 5), which may be a cobblestone floor or walkway, may be related to features described in the 1851 newspaper advertisement.

Because of the research potential and possible significance to understanding the domestic occupation in the middle 19th century of this end of Alexandria, further archeological work is recommended in these areas.

The previous Scope of Work (dated April 28, 2006 and revised May 1, 2006) called for consultation with Alexandria Archaeology regarding the significance of features and the need for additional testing. This additional work would involve a combination of trench expansion or stripping of larger area to expose significant features and the hand excavation of 5 x 5 foot square test units. The additional work was to be billed to the client on a per test unit basis.

The previous scope did not include the excavation of "deep shaft" features, i.e. wells or privies, nor for the conservation of artifacts. The goal of this Scope of Work is to outline the additional archeological work.

Additional Archaeological Testing

All aspects of this investigation will adhere to OSHA regulations and will comply with the *City of Alexandria Archaeological Standards* dated January 1996 and the *Secretary of the Interior's Standards and Guidelines for Archaeology and Historic Preservation*. All open excavation units will be fenced when no personnel are present.

The archeological excavation plan consists of stripping two excavation blocks in the western and eastern central portions of the project area (**Exhibit A**). The first block will be excavated over the cobblestone feature and will measure roughly 40 by 50 feet or a maximum of 2075 square feet. The block will be excavated to the depth of the cobblestones or roughly 3.5 feet

below the current ground surface. The entire feature will be mapped, photographed and evaluated. Test Unit(s) will be excavated over the cobblestone feature and additional features, such as post holes, will be excavated.

The second block excavation will explore the vicinity of the well feature, covering 35 by 50 feet (maximum of 1860 square feet). This second block will be mechanically excavated to a depth of roughly 5 feet below ground surface. At this time, the well will also be excavated.

Additional features are expected in the unexplored area between the two known features. A 50 by 5 foot machine backhoe trench (Trench 10) will be excavated in this area (see Exhibit A).

At the conclusion of archeological investigations, all excavation blocks will be backfilled.

Test Unit Excavations: At least one test unit, measuring five feet square (5 by 5 feet) will be excavated as part of this scope to test the potential buried ground surfaces. The test units will be excavated stratigraphically and all soil will be screened through 1/4-inch mesh hardware cloth screens. Soil profiles will be made of representative units, with soil colors described using the Munsell Soil Color Chart designations. Artifacts will be bagged and labeled by unit number and by soil horizon. The work will be documented with field notes, sketch plans, photographs, and slides. Any features encountered will be mapped and made available for inspection by Alexandria Archaeology.

Archival Research: Archival and historic research will provide context for the archeological work by examining:

1. water service in early Alexandria
2. technology of bored log pipes and water pumps

Laboratory Work and Curation

Archaeological artifacts recovered from the project area will be cleaned, stabilized (if necessary), cataloged, labeled and packaged in accordance with the guidelines set forth in the *City of Alexandria Archaeological Standards*.

At the conclusion of the project, all original photographs, negatives, slides, digital images, videotapes, copies of historical documents, field notes and forms (original copy and a duplicate copy), other field records, as well as the artifacts if they are to be donated to the City, will be delivered to Alexandria Archaeology. Archaeological collections recovered as a result of the Alexandria Archaeology Resource Protection Code must be curated at a facility which meets Federal standards for archaeological curation and collections management as described by 36CFR Part 79. The Alexandria Archaeology Storage Facility meets these standards, and the property owner is encouraged to donate the artifact collection to the City for curation. The archaeological consultant is responsible for arranging for the donation of the artifacts with the owner and will deliver the artifacts and signed forms to the appropriate storage facility.

Archaeological Evaluation Report

The Archaeological Evaluation Report will include the following: a public summary; the results of the archival and documentary research, a map of the project area; a map with unit locations and significant features; a summary of the procedures; results of the field investigation and artifact analysis, including a distribution map or other graphics which indicate potentially significant archaeological areas; an integration of the field and analysis data with the historical record.

When the fieldwork is completed, one copy of the full Archaeological Evaluation Report will be submitted to Alexandria Archaeology as a draft for review. Once the report is approved by the City Archaeologist, revisions will be made, and four copies of it, one unbound with original graphics, will be submitted to Alexandria Archaeology. The report will also be submitted on a CD. All site maps and drawings must be inked or computer-generated so as to produce sharp and clear images that will result in clear photocopies or microfilms.

Public Interpretation

The *City of Alexandria Archaeological Standards* require that a public summary be prepared as part of an Archaeological Evaluation Report. The public summary will be approximately 4 to 8 pages long with a few color illustrations. This should be prepared in a style and format that is reproducible for public distribution and use on the City's web site. Examples of these can be seen on the Alexandria Archaeology Museum website. A draft of the summary should be submitted to Alexandria Archaeology for review along with the draft of the Archaeological Evaluation Report. Upon approval, a master copy (hard copy as well as on CD or computer disk) will be submitted to Alexandria Archaeology. The summary and graphics should also be e-mailed to Alexandria Archaeology for publication on our web site.

In addition, if determined to be warranted by the City Archaeologist, the developer will be required to erect a historical marker on the property. The archaeological consultant will supply the written text and graphics for the marker. 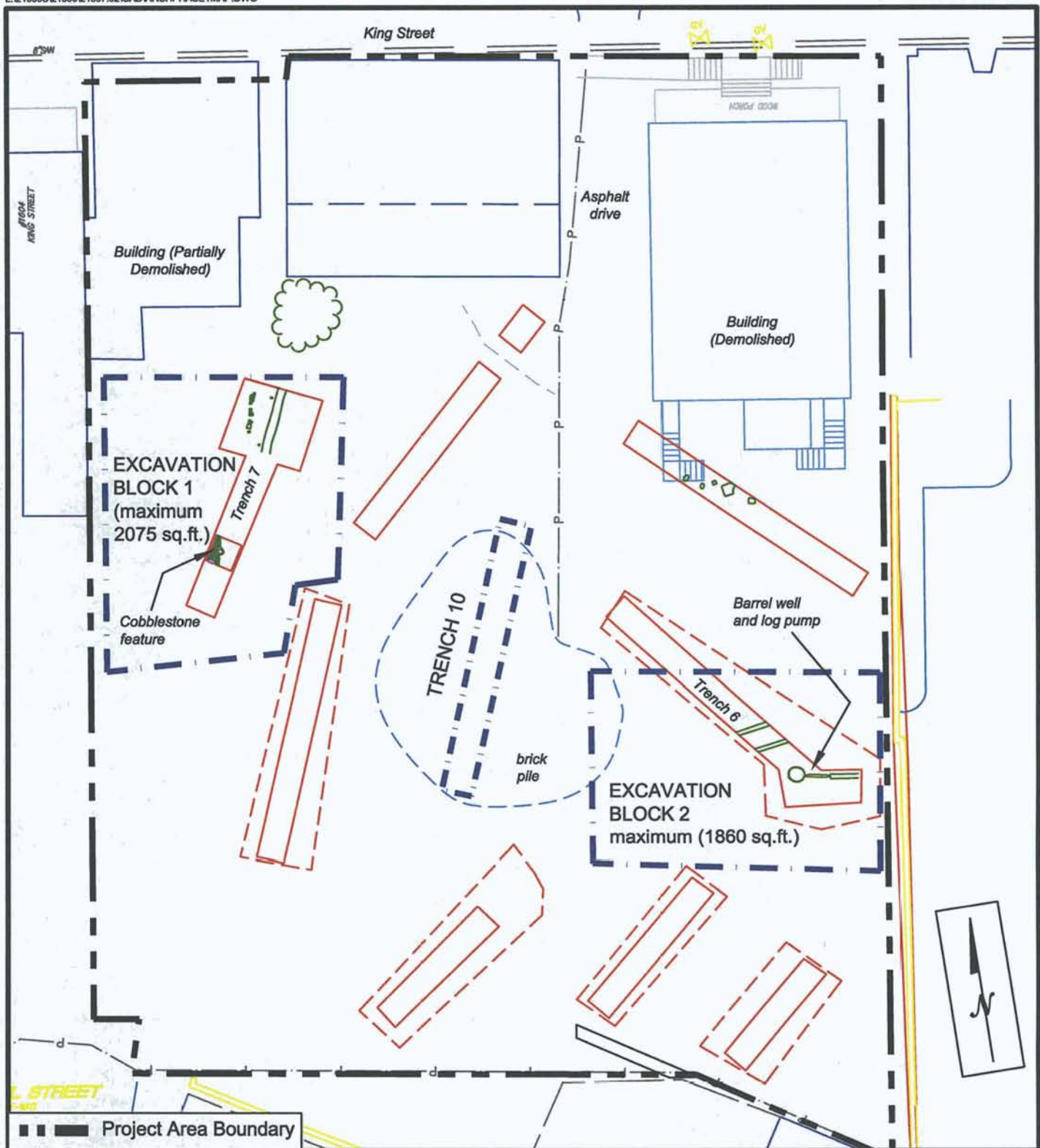

Survey Description:

Thunderbird Archeology, a division of Wetland Studies and Solutions, Inc. conducted Phase I-III archeological excavations at a 0.61-acre parcel located between 1514 and 1602 King Street and at 1602 Dechantel Street, Alexandria, Virginia.

In the initial phase of this investigation, eight trenches of varying length were mechanically excavated across the site, revealing deep historic fill deposits overlying subsoil. A total of 22 features were identified in six trenches that ranged in date from the 19th through the late 20th century, based on artifacts recovered from the associated historic fills. Additional testing around two of the 19th Century features was conducted. Two larger excavation blocks were mechanically stripped, exposing the features: a cobblestone walkway and/or drainage feature and a barrel cistern with associated wooden box culvert water system.

The site includes artifacts and features associated with the possible late 18th and 19th century occupations of this lot.

Assemblage Description:

(2007)All artifacts in the upper fills appear to be redeposited and are not included in these site only artifact totals.

Domestic artifacts dating from the 18th-20th century representative of several domestic dwellings and occupations during the history of the city block. Ceramic artifacts recovered from the project include ceramics ranging from pipe bowl and stem fragments, hard and soft paste porcelain including some (doll parts and toy tea cup fragments), pearlware (1780-1830), whiteware (1820-1900+), ironstone (1840-1900+), yellowware (1830-1940), redware, Rockingham/Bennington (1800-1910), and stoneware. White ware was the overall dominant dateable ceramic recovered including (173) 27%, followed by ironstone (89) 14%, and pearlware (43) 7% of the ceramic assemblage.

Glass vessels range from bottle and bottle/jar including (champagne-wine, flask, and perfume), tablewares included (tumbler and goblet). Glass technology dates range from contact mold (1810-1880), clear manganese (1880-1915), and automatic bottle machine (1907/1910-present). The highest numbers of dateable glass were contact mold (38) 7%, clear manganese (2) 0.3%, and automatic bottle glass (13) 2% of the glass assemblage. Windowpane includes soda crown (1852), potash, potash/soda, soda, and lime soda). Of the windowpane sherds (1864-present) included (40) 45%, and pre-1864 included (23) 26%.

The majority of the dateable nails included cut (post-1790), and cut machine headed (post-1830), with a few wire nails (post 1890). The dateable nails were dominated by cut machine headed including (43) 41%, cut (25) 24%, and wire (5) 5% of the total nail assemblage while (25) were unidentified.

Other metal objects included brass knob, buttons, cast iron, curry comb, lead, lead shot, coins (copper British George III farthing 1775) (U.S. brass small one cent, Indian head 1866), horseshoe, scabbard throat and finial, and stirrup.

Other artifacts included, bone, brick, cinder, coal, slag, shell, leather and leather shoe fragments, slate, and wooden (button, handle, cork). Prehistoric artifacts included quartz and quartzite partial flakes.

Artifact counts by category include 628 ceramics, 624 glass, 376 metal, 549 miscellaneous, and three prehistoric. Total artifacts recovered from the site 2,180.
