Vice-Chairman Batey called the meeting to order at 8:16 a.m.

The Minutes of the July meeting were approved without amendments unanimously.

#### **ALEXANDRIA ALLEYS SURVEY**

The next meeting is scheduled for August 22. Hellman gave an update on the Alleys survey, Which includes a slowing down of activity as the survey nears completion.

# **Freedom House**

The Northern Virginia Urban League is putting the building up for sale. The building is still dealing With mold remediation issues resulting from the July 8 floods.

#### HARC REPORT

Osborne said that HARC is creating a Public Easement Steering Committee which will be composed of representatives of the easement holding organizations. AHRPC is not required to participate. The desired goal is a ratio of 7.3 acres of open space per 1000 residents for new

development. The Historic Alexandria Foundation has filed a Lawsuit regarding 619 S. Lee Street. 56 Towers will be raised a maximum of 10 feet to accommodate 5G wireless. The details will be revealed in a BAR meeting on Sept. 4. The design of the Potomac Yards Metro station needs to be altered to connect the two roofs. Now is the input period on the City Hall renovation.

#### **OHA REPORT**

OHA is creating a new exhibit on the history of City Hall as it prepares for the renovation. The Freedom House and Lyceum had to deal with 3 inches of standing water in their basements.

# **City UPDATE**

Susan Hellman represented the Office of Planning and Zoning. She stated that the developers in the Ross Building and the Campagna Center projects have pulled out, citing too many restrictions. The NOVA Parks system owns the Bank of Alexandria building on the Carlyle House property. The 40 year lease expires on December 31, 2020, and the system is willing to sell or lease the building. Hellman wrote an easement proposal for the inside, which is now being used as office space. It was the first bank in Virginia, and includes the original vault.

#### **Easements**

Stevens began sending out inspection letters. Horne suggested sending out a blanket letter to all easement holders including FAQs and the chance to get a plaque noting their easement.

### **ACTION ITEMS**

Policy #8 was pushed.

The Commission has received a request from a lawyer representing one of the Lloyd House Neighbors asking for a submission of the property deed for the property. The Commission is dealing with the State Attorney General's office, which has been very responsive in this matter.
