<u>One Hundred Year Old Buildings</u>: This registry of officially designated buildings that are at least 100 years old, has recently attracted a lot of attention. The Director of Planning & Zoning has decided that we will now open up the process to the public. In the past, only staff recommended buildings to be added to the list. Now citizens may put buildings forward for listing. We will be putting the instructions

on the HP website shortly. To submit an application, the applicant must fill out an NR PIF and submit it to BAR staff who will review/evaluate it. If the application is complete and accurate, the application will go to the BAR. If the BAR approves, it will then go to Planning Commission, and then to City Council. If City Council approves, they will craft a ordinance designating the property. It's a pretty long and involved process. Currently, we have 34 100YOB. <u>215 N. Patrick cell facility appeal</u>: This goes to Council this Saturday, May 15. Staff supported the application, but the BAR denied it. The applicant has appealed to Council.

Stevens will need to be replaced as inspections coordinator, but Smith and Anthony wanted time to think about it, since they have not done an inspection themselves.
