The virtual meeting was called to order by Linda Lovell at 7:03 p.m. via Zoom Webinar.

## **Reading of Virtual Meeting Notice**

Condolences are given for the loss of Joe Shumard. Joe was the Chair of the George Washington Birthnight Committee, President of Friendship Firehouse Friends Group, and one of the creators of First Night. Overall, his passing is a huge loss to the City of Alexandria.

Andrea Tracey, Director of Carlyle House, has applied to City Council as a member of HARC. Shawn Eyer representing the George Washington Masonic Memorial is welcomed back to HARC (waiting for official confirmation.)

# **Approval of Minutes for September 15, 2020**

## **Chairs Update**

### **Old Business**

<u>River Renew – Ivy Whitlach</u>

Currently, no slot for preservation community on the stakeholder's group. Whitlach has applied and is waiting for approval.

RTN Demo Tour video (https://vimeo.com/459145569). Video explains the following:

- CSO 1 (end of Pendleton overlooking Oronoco Bay)
- Reason for demolition of Robinson Terminal North as well as brief history of site
- Overview of 3 locations in the system including tunnel at River Renew.

Boring will occur at River Renew facility and boring tunnels will occur at CSO 2 & 3. Archaeology will be included whenever ground is disturbed.

CSO 1 (7 ft. wide shaft, 10-12 ft. tunnel) – Archaeological findings likely

CSO 2 & 3 – Not as likely

Path of tunnels (skirting the Potomac and turning at Jones Point) was deliberate, in order to minimize disruption to historic district.

## <u>Virtual Ramsey Homes Symposium – Co-Chair Lovell</u>

Opened with brief history of Ramsey Homes. Symposium was scheduled to take place this past May. Virtual symposium will take place February 11, 2021 from 9:00 a.m. - 3:30 p.m. Will be free of charge, but attendees must register. There will be several talks on public housing, genealogy of residents, and the fab-crete construction process. Event will end with a virtual tour of the new facility.

# **Heritage Apartments**

Michael Hobbs and Martha Raymond drafted a letter to the Board of Architectural Review, which was circulated to HARC members via email prior to meeting.

Carol Black advised that the phrase, "urban renewal" be avoided, as well as any connection to the appeal of the demolition permit. Also, letter could be shortened, saving greater detail for a situation where further testimony is needed.

Ivy Whitlach proposed that HARC has a unique position concerning properties adjacent to historic districts therefore, HARC should make a case regarding boundaries and perimeters of historic districts. Posed the question, how can HARC put this in front of the planning commission as much as BAR?

## **Board of Architectural Review Update – William Conkey**

# Heritage Apartments Continued -

Currently in the Concept Review phase – a voluntary, non-binding process for large development projects. Created to give early feedback on mass, scale, height, and general architecture. Next phase goes to Planning Commission, then City Council. Final phase goes back to BAR for the Certificate of Appropriateness which is binding and necessary. Next BAR meeting will be held on October 21 for the third concept review. Current plan addresses broad architectural character, and design intent. Developers have reconfigured massing – moved taller parts of the building away from the historic district. Conkey referenced the city's Housing Master Plan which addresses affordability. Two of the nine blocks envisioned in this plan are located in the historic districts. Still in the early phases of the project.

Conkey recommends HARC submit their letter to the BAR by mid-day October 21. Board members will be able to view letter before meeting. There will be a public comment segment during the meeting – a representative should use this as an opportunity to highlight points. The unified voice of HARC has weight. Stressed again that the project is still in the concept review

phase and their will be more opportunities to weigh in on issues. Confirmed the project will set a precedent.

On a motion by, Danny Smith seconded by Martha Harris, HARC voted via Zoom Poll to submit the *Heritage at Old Town* letter to the BAR after editing, along with Smith's verbal statement at the October 21, BAR meeting.

Hobbs thanks OHA and Visit Alexandria for the *Courageous Journey – A Guide to Alexandria's African American History* pamphlet, which he referenced when writing the letter.

## Town Hotel – William Conkey

Will be moving historic house approximately 19 feet over. Wolfe House & Building Movers, LLC. will be working on this project. There has been some demolition to the house due to compromised structural issues.

## OHA Report - Gretchen Bulova

- Budget planning for FY22 (10% reduction scenario)
- Temporary Waterfront Historian, Abby Schreiber, to document the chain of title for all properties between the waterfront and Lee Street, between Prince and Queen Streets. This will help us determine potential archaeological concerns as the City plans their flooding remediation.
- Freedom House Update
  - a. OHA has been included as a member of the International Sites of Conscience
  - b. State funding approved by the General Assembly, awaiting signature by the Governor
  - c. HSR final section being made
  - d. Master Plan should go to bid in November
  - e. Completing the chain of title for the property and a history of the site
- African American Heritage Trail has received rave reviews and lots of press
- Loving marker installed. Sadly, Bernie Cohen passed away last Monday October 12, 2020.
- Parker Gray 100<sup>th</sup> anniversary bricks are being sold and there will be a ceremony to unveil the Parker-Gray Memorial Walkway at a dedication ceremony on Saturday, October 24, from 2 to 3 p.m., at Charles Houston Recreation Center (901 Wythe St.).
- Roof repairs have started at Fort Ward will notice protective site fencing when driving by
- The Lyceum interior will be repainted in November site will close on Nov 2 through end of 2020. The Apothecary Museum will open in its place. Both Gadsby's and the Apothecary will open on Mondays until public schools resume in person classes to provide field trip opportunities for local families.
- Bulova received Gov. appointment to State Revolution 250 Commission, 2026 anniversary
- Reeder's House working to replace roof and digitally documenting house.
