#### **CALL TO ORDER:**

# **Approval of Minutes for June 15, 2021**

## Thank You Letter to City Council, ARPA Funding

The American Rescue Plan Act allocated \$600,000 to history related projects in Alexandria. Chairman Smith and Vice Chair Lovell will draft a thank you letter.

#### **Old Business**

## **OHA Deaccessioning Process**

Deferred until next HARC meeting in September. Current Chair of Living Legends, Jeanne Theismann accepted HARC's invitation to attend the September meeting to present her arguments for deaccession.

## **Justice Black House Update (Gail Rothrock)**

- Permits were issued; work can begin on existing structures, which includes demolition of curved wall and kitchen.
- Martha Raymond notified HARC of a Facebook post made by the group, "Stop Overdevelopment in Northern Virginia," which references the Justice Black House – Supreme Court case.

Facebook post (Martha Raymond stated she will email the full post to HARC members): On July 16, Arlington judge DiMatteo dismissed our lawsuit against Arlington County Board's rejection of local historic designation of the Febrey estate saying that only property owners of a

historic property or a property owner of an adjacent property has any appeal rights and citizens have no rights to appeal denial of historic status.

# Elks Lodge Update (Carol Black)

- Preservation Virginia has agreed to make a banner for Elks Lodge.
- A future HARC meeting will be held at the Elks Lodge (possibly in October) with a short tour beforehand.

# **GenOn Power Plant Update (Sam Hoffman)**

No new updates.

# **River Farm Update (Danny Smith)**

• River Farm is currently owned by the American Horticultural Society. Their board of directors are divided on whether or not to sell the property. Whether River Farm continues to be the home for the American Horticultural Society is uncertain, but the site will most likely remain open to the public either way.

# **Standing Committee Reports**

## Advocacy Committee - Martha Harris, Co-Chair

• Last meeting was held on July 6.

# Heritage Project (major subject)

- HARC remains concerned about the project. The committee recommends that HARC send a copy of previous letter and add additional points for presentation at the upcoming BAR meeting subsequently rescheduled for July 29.
- Michael Hobbs, in particular, has developed additional talking points for HARC's
  comments (presented by Chairman Smith) at the meeting. Those points emphasize that
  city zoning ordinance requires new structures in the Old and Historic District to be in
  harmony with their historical and architectural surroundings, and that they not overwhelm
  adjacent buildings.

On a motion by, Michael Hobbs seconded by Martha Harris, HARC voted to request Chairman Smith keep his public comments, regarding the Heritage Project, at the July 29 BAR meeting consistent with previous comments he has made on behalf of HARC.

# Torpedo Factory

- HARC commissioners are encouraged to watch the recorded City Council session held on June 22 to understand the strong concerns raised by some council members about the vibrancy study and the "lack of trust" with artists.
- Mayor Wilson expressed dissatisfaction with the length of time the process is taking.
- At the end of the meeting a vote was taken, but was not recorded in the official minutes. The minutes reflect a study was simply "presented" to the Council.
- Gretchen Bulova has repeatedly communicated HARC's interest in participating in stakeholder discussions and the Advocacy Committee hopes that Linda Lovell (HARC's

representative) will follow closely and communicate with the committee as meetings are organized with stakeholders.

#### Justice Black House

- Discussed the unsatisfactory ruling of the VA Supreme Court on the Justice Black House, denying the Historical Alexandria Foundation standing.
- Gail Rothrock will keep HARC posted on the issue as it evolves.

# Availability of Housing in Alexandria, Sam Hoffman

- Researched the supply in the housing market, specifically multi-family homes in order to understand the need for affordable housing.
- Looked at new construction developments, which include thousands of units in the next 5-6 years.
- HARC should consider whether city should provide subsidies/incentives for historic preservation and if the city should engage in conversations about historic designations with developers.
- Old Town office market is experiencing 26% vacancies. Many buildings are currently empty. Should some office buildings undergo rezoning for adaptive reuse and residential use?
- This research will be useful when speaking with planning commission, city council and BAR.
- To Do: Carol Black, Ivy Whitlach, and Deborah Osborne shared various resources and experts to speak with; commissioners should send their suggestions to Chairman Smith.
- The city is considering making the 100 Block of King Street a permanent open pedestrian space. How will this impact the 100 block of Prince Street? The cobblestone road will see an increase of redirected traffic, which will advance wear and tear. Should this be considered in the City Council decision?

# OHA Support Committee – Steve Stuart, Chair Ad Hoc, HARC Composition – Richard Klingenmaier, Chair

Handouts of full report and draft were distributed to HARC commissioners.

# Alexandria, VA Code of Ordinances

- The present City Ordinance creating HARC provides for twenty-six seats on the commission. These seats are as follows:
- <u>Category A City Commissions</u>; four representatives
   <u>Category B History Organizations</u>; ten representatives

   <u>Category C Other</u>; twelve representatives; Tourism and Business, Art-Affiliated
   Groups, At-Large: seven, of which at least two are members of Alexandria civic
   associations and at least two are appointed from each of the three planning districts of the
   city; Historic Site Volunteer

HARC Ad-hoc Subcommittee on Composition – Recommendations

- A. Specified seats for the following organizations currently represented on HARC should be discontinued from the Commission through attrition as their representatives' terms of office expire because 1) the organization has declined to designate representatives for years 2) the organization is no longer active and able to designate representatives, 3) the organization is a single member of a larger class with other organizations that merit equal consideration for representation, or 4) the organization's primary interest is not in the protection of historic resources within the scope of the Commission's charge per se, but on a broader artistic, cultural or social interest. These organizations are:
  - \*Alexandria Convention & Visitors Association
  - \*Alexandria Society for the Preservation of Black Heritage
  - \*Mortar & Pestle Society
  - \*Northern Virginia Fine Arts Association
  - \*Torpedo Factory Artists Association
  - \*Alexandria Chamber of Commerce

#### B. At-Large Representation:

In order to comply with the requirements of the present Ordinance (a total of no more than seven at-large representatives, but including two from civic associations and two from each of the three planning districts), it is necessary that at least two of the seven at-large members be both a member of a civic associations and a resident of one of the planning districts – a formulation that has proven to be awkward and confusing in practice.

The committee recommends that the number of representatives from each category be specific, precise, and not overlapping, and further recommends reducing the number of At-Large representatives from the three Planning Districts from two to one each, and Alexandria civic associations from two representatives to one.

#### C. Business Representation:

With discontinuation of the seat specified for the Alexandria Chamber of Commerce, the number of representatives from the business community would be reduced from two to one.

## D. Historic Churches:

Currently, two churches (Christ Church and the Old Presbyterian Meeting House) are represented on the Commission in the category of "history organizations." The committee recommends that, when the terms of the current representatives of the two designated churches expire eligibility for appointment to two "historic church" seets be

designated churches expire, eligibility for appointment to two "historic church" seats be broadened to encompass "two representatives of houses of worship, congregations or sites which have played significant role in the diverse cultural, social and religious history of the city."

#### E. Volunteers at Historic Sites:

The commission currently has "one member who serves as a volunteer at an historic property or attraction which is open to the public on a regularly scheduled basis."

However, the committee notes the value not just of individual volunteers, but also of members of "Friends" or similar organizations that help support historic properties, both private and city owned. Therefore, the committee recommends that the number of "volunteer" representatives be increased from one to two as follows:

- 1. One representative who serves as a volunteer at a public or private historic property or attraction which is open to the public on a regularly scheduled basis.
- 2. One representative who is a member of a "support" organization for a public or private historic property or attraction which is open to the public on a regularly scheduled basis.

# F. Community Organizations:

The present ordinance specifies a seat under "Category B – Historic Organizations" for the Alexandria Society for the Preservation of Black Heritage, Inc.; but the society has not been active for some time, and the seat on HARC has remained vacant. The committee recommends that the vacant seat be designated instead as representing the general category of "Community Organizations", and that eligibility be extended to one member whose qualifications, or membership in a relevant community organization, reflect the importance of the city's diverse social, ethnic and cultural heritage, as well as its sites and structures, among Alexandria's historic resources.

#### G. Transition:

The committee recommends that transition from the present to the proposed composition of HARC be accomplished by attrition: i.e., that no member's service on the Commission be discontinued before the conclusion of the term to which they have previously been appointed and are presently serving.

#### H. Quorum Requirements:

The committee reviewed an analysis of the effect of the Commission's membership size on the Commission's ability to meet quorum requirements. The committee concluded that quorum requirements would not be negatively affected by either an increase or a decrease in the Commission's size.

## Open Discussion:

- **D- Historic Churches** Could be potential problems with determining what a "house of worship, congregation or site" is. Also, could run into an issue of subjectivity regarding their significance.
- **B At large representation** Concerned with the reduction of Planning District representatives from two to one. The Planning Districts will be underrepresented.
- The reasoning behind reducing the Planning District's representation is that since HARC members are required to be city residents, the planning districts are already represented by all commissioners
- Reducing the number of commissioners from 26 to 19 is an attempt to be more agile.

- HARC members express they are not confident the new composition will guarantee a more diverse or efficient commission.
- Should take a step back and create a mission statement/objectives. Clarify goals for the new composition.
- Chances of influencing City Council increase by creating a more functional commission.
- Should actively recruit new commissioners and consider a more enthusiastic approach towards public engagement to reach communities who are unaware of HARC.
- By cutting back on Planning District representatives, the chance for diversity actually decreases. There are residents who are not members of other organizations and would have no other means to join a commission other than at-large representation.
- The new proposed HARC composition accounts for a 26% 27% overall reduction and a 50% reduction in the At-Large seats.
- After HARC agrees on a new composition, it will need to be approved by the City Attorney and will require a change to city ordinance. The changes would not go into effect for at least a year.
- HARC members should review the proposed composition and be prepared to continue the discussion at the September meeting.

# Bylaws - Sam Hoffman, Chair

- City has asked all commissions to prepare bylaws.
- At the first meeting members examined other city commissions.
- Next step is to create a rough draft which will be distributed to HARC before September's meeting.

Finished concept reviews. Will now go before City Council and Planning Commission Will be a residential multi-family development.
