Approval of Minutes for October 19, 2021

On a motion by, Michael Hobbs seconded by Tom Soule, HARC voted to approve the minutes with edits from the October 19, 2021 meeting.

Chairs Update

- Welcome to new member, Mark Farkus, representing District II
- Planning Department Presentation Chair Smith noted that the Planning Department provided an excellent description of their process related to historic preservation.
 However, review of their inventory of projects revealed that it is difficult to understand.
 Bill Conkey agreed to provide additional guidance.
- Planning Commission Meeting in regards to the permanent closure of 100 block of King Street HARC is concerned with the unattended consequences of the 100 block of Prince

Street. Council stated the issue can be addressed later on, after the initial ordinance change. We will need to follow-up at a later time.

Elks Lodge Update (Carol Black)

- Meeting held on October 23rd at Elks Lodge.
- Commissioners have reviewed draft letter to Mayor & City Council, the City Manager, and Transportation and Environmental Services regarding water intrusion at the Elks Lodge #48.
- Commissioner suggestions to the letter:
 - o Change HARC "members" to "commissioners"
 - o Consider sending to Flood Advisory Board consists of community members.
 - Add background on historical importance of Black Elks. Aligns with HARC's mission to preserve cultural and social history.

On a motion by Carol Black, seconded by Mark Farkus, HARC voted and approved the Elks Lodge Letter be sent to City Council, the City Manager, and Transportation and Environmental Services after revisions are made to reflect the discussed suggestions.

Heritage Old Town Apartments

- BAR denied Certificate of Appropriateness.
- Applicant appealed to City Council. Vote was unanimous to overrule BAR decision.
 Certificate of Appropriateness was granted by council.
- Gail Rothrock testified on behalf of HAF.
- Carol Black expressed her concern over the behavior of Mayor Wilson when addressing residents who voice opposition.

Advocacy Committee - Martha Harris, Co-Chair

Torpedo Factory - Draft Letter to Mayor and City Council

• Edits/suggestions to the letter:

- Page 3, "Similarly, substantial alteration of century-old buildings, or to others which make a particularly important, defining contribution to the historic character of the city, ordinarily involve special attention from the BAR."
- Concentrate on historic district and structure. The Artist Collaborative is significant to social and cultural history of the city.

On a motion by, Gail Rothrock seconded by Martha Raymond, HARC voted to approve the TFAC Implementation Strategy letter be sent to the Mayor and City Council, then made available to the public via press release.

- Look at the Torpedo Factory website's Frequently Asked Questions Implementations and Strategies. Gives context to the entire project.
- Commissioners should use the letter to advocate individually.

Jones Point

- NPS owns the lighthouse.
- Send letter to Mayor and City Council alerting of them of the issue. Do not directly contact NPS. Council members will get in touch with the appropriate NPS officials.
- Minor and immediate maintenance could include painting, removing rotted wood and protruding screws.
- Commissioners can contact NPS individually.

On a motion by Michael Hobbs, seconded by Gail Rothrock, HARC authorized the Advocacy Committee draft a letter to the City Council and appropriate city departments emphasizing the urgency of Jones Point restoration and repairs. Letter can be approved and sent by Co-chairs.

 - Bulova provided comment and background on the Washington Post article, A
 Robert E. Lee Historical Marker Vanishes in the Dead of the Night. The old
 marker, "Lee's Boyhood Home" will be replaced with "Potts-Fitzhugh-Lee
 House," a revised marker that more accurately reflects the history of the home.
 Both markers are in the City's possession.
