Ivy Whitlatch - Alexandria Archaeological Commission

- Will be creating a new logo.
- John Chapman in favor of change in city ordinance, "Society for the Preservation of Black History or an equivalent organization." Will allow for more opportunity of African American representation.

Deborah Osborne - Alexandria Historical Restoration and Preservation Commission

- Tour given by Al Cox of the historic fabric and architectural characteristics of significant historic properties. There was a north route. Will ask if HARC members can join tour of south route.
- Looking to add easements on African American historic sites. The Hepburn House, George Seaton's house, and the property on the corner of Oronoco and Washington Street are being considered.
- Beginning to address multigenerational change in perceptions of historic preservation. Need to reach younger generations.

New Business

Revitalization of the TFAC

- Sent "Torpedo Factory Art Center Implementation Strategy" letter to Mayor and City Council on November 11th. Mayor and Vice Mayor acknowledged receipt of letter.
- Resubmitted letter to Clerk of Council before December 14th meeting. Letter not posted to meeting's agenda.
- Mayor Wilson prepared a memorandum on the "Torpedo Factory Next Steps" which laid out principles for administrative restructuring. Did not include any mention of architecture or history.

Action Item: Chair Smith asked Gretchen Bulova to distribute City Council memo to HARC Commissioners.

- Any proposed changes/modifications to the building must be approved by BAR.
- OHA & BAR stance City Council respects historic significance. Being located within
 the Old & Historic District does provide some protection. BAR does not have jurisdiction
 over the interior.
- The original artists contribute to the cultural and social history of Torpedo Factory Art Center.
- Bulova will continue advocating for HARC and OHA representation on the stakeholder's group.

Old Business

Jones Point Lighthouse Letter to City Council

- The Advocacy Committee's, "Jones Point Maintenance" letter was sent to Mayor and City Council on December 2nd. Mayor Wilson will get in touch with National Parks Service (NPS) for plans of near-term restoration or better maintenance. City Manager will have staff conduct a visual assessment.
- General Services in consultation with OHA followed up with assessment and email. NPS stated they will follow up within 30 days.

Elks Lodge Update
