I conduct performance audits of federal law enforcement agencies and have a couple recommendations for expanding the Board's authority to ensure it can meet the ordinance's goals: 1) Section 2-4-221(d) of the proposed ordinance gives the Board access to all records, documents, and materials as needed. Relevant City/APD officials should also be made available as needed for the Board's reviews, to be interviewed to provide context for these documents. 2) In the current draft of the ordinance, APD must issue a public written statement explaining why it is not implementing a recommendation from the Board. The ordinance should be amended to also require APD to provide public written statements for recommendations that it has implemented, explaining how APD actions meet the recommendation. The Board should then determine whether the recommendation was sufficiently implemented and can be closed, or should remain open as yet unimplemented. Without this addition, the public will not receive closure on many Board recommendations, or assurance that recommendations were fully followed.

I challenge all council members to provide specific instances of unaddressed police misconduct in Alexandria that requires this drastic change to APD. As local government officials you should be working to address issues occurring in Alexandria. APD needs a review board as much as the Fire Department needs a Mountain Rescue Team. Instead, this proposal makes unneeded drastic changes to a City agency that is widely respected under its current model. create a recruiting and retention nightmare for APD in which the best employees and candidates will not come here. If city leadership openly thinks so little of APD, why would the best and brightest officers want to stay with APD or come to Alexandria to begin with?

Furthermore, as seen around the country, crime will skyrocket in Alexandria once this is passed. Officers will do no more than the bare minimum. And who could blame them, knowing that all of their decisions will be sent to a hostile review board to be scrutinized by people who are ignorant to their profession.

City council has missed the mark entirely with this proposal. It will have a long lasting negative impact on public safety and quality of life in Alexandria.

Please provide feedback on the proposed hybrid model used in the draft Community Policing Review Board Ordinance for Alexandria. While I comment the Mayor and City Council for declaring the city's intent to establish a policing review board (CPRB) which puts Alexandria in the forefront of urban policing reform efforts, I do not believe that the proposed "hybrid" model goes far enough. I was able to view the presentations of the staff's draft ordinance and the discussions that were a part of the Community Engagement on the evening of March 3, 2021. I concluded that the model that is being proposed, while perhaps offering a reasonable compromise, is a disappointment. There seems to have been little or no significant consideration of the more robust "investigative" model of review board which would allow for more in-depth investigation of matters brought before the board and also give the board real authority to enforce its recommendations. This model is widely recognized as a more transparent and therefore more trustworthy method of providing civilian review of complaints about police actions. It was not made clear on March 3 why this model is not being more actively considered. I would strongly encourage the Council not to limit its vision of the planned change in approach to policing oversight but to aim to go higher and deeper into real reform rather than settling for a compromise at the very outset.

Please review the chart and provide your feedback on any elements of other models that should be considered in Alexandria. The availability of binding enforcement authority should be considered.

Please provide feedback on the proposed hybrid model used in the draft Community Policing Review Board Ordinance for Alexandria. I commend Alexandria's Mayor and City Council for adopting Resolution 2950 on June 9, 2020, declaring their intent to establish a community policing review board (CPRB). As of 2018, only approximately 200 of the over 3000 law enforcement organizations (LEOs) in the United States have established CPRBs, and it is significant the Alexandria Police Department will be among those relatively few LEOs.

I viewed staff's presentations to Council on draft CPRB ordinances, and the discussions that followed, that occurred on the September 8, 2020, and January 12, 2021 Council meetings, and attended the Community Engagement presentations on February 27 and March 3, 2021. While staff did not recommend the relatively weak "Review" model of CPRBs, staff also did not recommend the most robust model of CPRBs, that is, the "Investigative" model. The robust Investigative model of CPRBs is recognized as the most transparent model of CPRBs, and the model that engenders the most community trust. While an investigative CPRB is more costly than the proposed "Hybrid" board model, these are not the times to be considering a weaker board model based solely on cost. Potential costs of community trust (and, perhaps, lives) are immeasurable.

I posed the question to staff during the February 27 Community Engagement meeting about staff's choice of a hybrid board model over an Investigative board model. Unfortunately, the staff member misspoke in her answer, replying that an investigative board would be saddled with such issues as time and attendance violations and computer misuse. To be clear, the span of authority of a board of any model can be codified in an ordinance, and can be limited to those items deemed to be most important to a community, and typically the types of external complaints investigated include use of force, officer-involved shootings/deaths, and abuse of police authority. Many types of internal complaints or violations can be excluded from an ordinance.

The September 8 and January 12 Council discussions were focused on aspects of the proposed hybrid board model, and included very little, if any, discussion of the advantages of an investigative board when compared with a hybrid board. It is of the utmost importance that Council fully considers a resolution that puts into place a CPRB of the robust investigative model.

Please review the chart and provide your feedback on any elements of other models that should be considered in Alexandria. There are some misleading elements in this chart. Some examples:

- -Not necessarily accurate to say Full Investigatory Boards use subpoenas "frequently." Boards of this model, as well as hybrid boards, both can and do use them as needed.
- -Not accurate to say that if an Alexandria CPRB was of the investigatory board model, it would no longer conduct any investigations. The parenthetical statement is the accurate one, and an ordinance can and should define the kinds of complaints investigated by a board. The kinds of complaints investigated should be primarily those that are generated outside of the APD, are serious in nature, and should not be used as a replacement for addressing of more routine internal personnel matters.

Further, the absence of binding disciplinary in the proposed model would make the review board even weaker than other hybrid models in the nation, and is in alignment with the weakest board model (the review model). Is this what Alexandria wants, that is, a board that would be so weak that it would not be viewed with any significant amount of trust from the community? Why even stand up such a weak board?

The second-to-last argument posed as a "con" to an investigatory board can and should be viewed as a "pro." The point of a strong community board is to be transparent and unbiased, and that includes removing the possibility of the investigated party imposing discipline on itself. There is no way around the issue of bias if the APD is allowed to monitor and police itself. The latter is exactly what has gotten our nation to the place it is regarding the historic and extraordinary negative impact of policing on members of BIPOC communities. The final "con" argument should not be a position that the City would find itself in. It is up to the Mayor and Council to alleviate the possibility of an adversarial relationship.

It is extremely concerning that the Council has not had a complete and thorough discussion of the benefits of an investigatory board over the hybrid model currently proposed. To date, it has only discussed the various hybrid models presented to it by staff. To best serve our community, a board of an investigatory model must be fully vetted.

Thank you for this opportunity to provide comments. To reemphasize a point I made in previous sections, a draft ordinance defining an investigatory board model must be discussed and debated by Council, and must be presented to the community in such a way as to gain the most amount of thoughtful input, especially from those historically most marginalized in Alexandria.

Please provide feedback on the proposed hybrid model used in the draft Community Policing Review Board Ordinance for Alexandria. I am pleased Alexandria is on the cusp of establishing a community policing review board. These boards can be a critical element in providing accountability and increasing trust in policing. We shouldn't be lulled into believing that we are in good shape in Alexandria and these types of measures are unnecessary. Rather, we should welcome this community oversight as another strong indicator that our city is deeply committed to responsive and accountable policing.

And a deep commitment to community oversight requires that we give the community review board the maximum investigative powers needed to act when a policing incident is under question. I've watched the last few years when half-measures failed to bring justice to communities. It is still too easy for public leaders in a tough spot to stop short of a thorough investigation and full access to justice. Then the community feels twice misused, first in the incident and then in the investigation.

Let's not accept half-measures here in Alexandria and establish a community review board that has the full powers it needs to review any inappropriate or excessive policing. We need a review board with full investigative powers to reassure our community that justice will prevail in every situation. An impartial, empowered review board can deliver that assurance.
