3 AN ORDINANCE to amend Chapter 4 (COMMITTEES, BOARDS AND COMMISSIONS) of
4 Title 2 (GENERAL GOVERNMENT) of The Code of the City of Alexandria, Virginia, 1981, as
5 amended, by adding a new Article AA (INDEPENDENT COMMUNITY POLICING REVIEW
6 BOARD) and to amend Article A (GENERAL PROVISIONS) of Chapter 1 (POLICE
7 PROTECTION) OF Title 4 (PUBLIC SAFETY) of The Code of the City of Alexandria,
8 Virginia, 1981, as amended, to add Sections 4-1-5 (INDEPENDENT POLICING
9 AUDITOR/INVESTIGATOR) AND 4-1-6 (INDEPENDENT POLICING
10 AUDITOR/INVESTIGATOR DUTIES AND RESPONSIBILITIES).

11
12 THE CITY COUNCIL OF ALEXANDRIA HEREBY ORDAINS:

13 Section 1. That Chapter 4 of Title 2 of the Code of the City of Alexandria, Virginia, 1981, as
14 amended, be, and the same hereby is, amended by adding new Article AA, “Independent
15 Community Policing Review Board,” as follows:

16
17 ARTICLE AA – INDEPENDENT COMMUNITY POLICING REVIEW BOARD

18 **Sec. 2-4-220 Independent Community Policing Review Board**

- 19 (a) There is hereby established a commission to be known as the Independent Community
20 Policing Review Board (“Board”). The operation of the Board established pursuant to
21 this ordinance shall be consistent with Virginia law and regulations.
22

23 **Sec. 2-4-221 Board Purpose and Scope**

- 24
25 (a) Purpose: The purpose of the Board is to enhance policing legitimacy and to increase and
26 maintain trust between and among the police department, city council, city manager and
27 the public. The Board shall: provide timely, fair and objective review, investigation and
28 evaluation of policing policies, practices, procedures, and outcomes in Alexandria;
29 provide meaningful assessments and corrective recommendations intended to remedy
30 discriminatory practices, including racial and social inequities, that it may find; ensure
31 the protection of all communities through recommended actions and reform, including in
32 the criminal justice system; and recommend strategies for effectively implementing these
33 reforms in our community.

- 34
35 (b) Scope: The Board shall have the authority to investigate the matters as assigned in
36 Section 2-4-227, review investigations completed by the Alexandria Police Department
37 (APD) for certain matters, and evaluate policing practices, policies, procedures, and
38 outcomes in Alexandria, issue findings [to the public](#), and provide actionable
39 recommendations to the city council, the city manager, the school board, the school
40 superintendent, APD and other public agencies regarding appropriate discipline, policing

1 practices, policies and procedures in Alexandria. The Board is hereby authorized to
2 perform the following duties:

3
4 (c) Procedural Memorandum of Understanding: In order to carry out its scope and
5 authorized functions and to define in more detail the process and terms articulated in its
6 scope, the Board shall enter into a memorandum of understanding (“MOU”) with the
7 APD. The MOU shall be signed by the police chief and the city manager. The MOU shall
8 define the terms of the relationships and mutual obligations between the Board and APD.
9 Additionally, the Board is authorized to enter into an MOU with any other agency in
10 support of Board investigatory authority.- The Board is authorized to negotiate the
11 provisions of these MOUs, assisted by the city council appointed Independent Policing
12 Auditor/Investigator, and the City Attorney’s Office. If a provision of these MOUs
13 conflicts with a provision of this enabling ordinance, the provision of the enabling
14 ordinance shall govern.

15
16 (d) Access to APD Records: The Board and through the Independent Policing
17 Auditor/Investigator, shall be provided full access to all APD reports, files and records
18 related to the Board’s investigation or review of complaints filed with the Board or with
19 APD. All records, documents and materials in the possession of APD or the City that are
20 determined by the Board to be necessary and requested by the Board to carry out its
21 scope and authorized functions shall be provided in unredacted form. If such documents
22 contain confidential information such as Personally Identifiable Information authorized to
23 remain confidential pursuant to the Virginia Freedom of Information Act, the information
24 may be reviewed in a closed session of the Board in order to maintain the confidentiality.
25 If the documents requested are part of a criminal investigative file for an active criminal
26 investigation which could be compromised by the revelation of the process, evidence,
27 methods, scope, or other factors in such investigation, APD shall not be compelled to
28 provide such documents to the Independent Policing Auditor who shall not provide it to
29 the Board or share with the public until at until such time as the investigation is completed
30 or a determination is made that the criminal investigation will no longer be compromised.
31

32 (e) Budget: In order to carry out its duties the Board and Office of the Independent Policing
33 Auditor/Investigator shall be provided an annual budget subject to appropriation by City
34 Council, and shall expend the funds provided consistent with:

- 35
36 i. the purposes and scope of the Board and of the Office of the Independent Policing
37 Auditor/Investigator;
38 ii. the MOU with the APD required herein;
39 iii. ii. the budget and appropriation approved by City Council; and
40 iv. iii. city procurement and expenditure regulations and practices.

41
42 ~~(f) Board Reports: The Board shall produce public reports regarding the work of the~~
43 ~~Board and disseminate such reports in hardcopy and online after each investigation,~~
44 ~~including, but not limited to, a written report to the City Council by September 1 of each~~
45 ~~fiscal year of its activities for the prior fiscal year under the provisions of this chapter~~
46 ~~along with any comments and recommendations as it may choose to make.~~

1 (f) Board Reports: The Board shall produce public reports regarding the work of the Board
2 and disseminate such reports in hardcopy and online, including, but not limited to:

3 i. a written report to the City Council by September 1 of each fiscal year of
4 its activities for the prior fiscal year under the provisions of this chapter
5 along with any comments and recommendations as it may choose to make;
6 and

7 ii. a written report after each investigation conducted pursuant to Section 2-
8 4-227(d) which shall not include any Personally Identifiable Information, or
9 criminal or juvenile information prohibited from being disclosed by Virginia
10 State Code or Federal Law. The reports of each investigation shall be
11 provided to the public with all narratives, findings, recommendations and
12 any disciplinary actions.

15 (f) Other Duties: Undertake any other duties as reasonably necessary for the Board to
16 effectuate its purpose as defined in this ordinance;

20 **Sec. 2-4-222 Board Member Requirements and Term of Office**

21
22 (a) The Board shall be composed of seven voting members appointed by the City Council,
23 which shall endeavor to create a fair, objective, independent, diverse, and representative
24 body which shall reflect the demographic diversity of the City.

25
26 (b) The seven voting members of the Board shall be residents of the City of Alexandria and
27 shall demonstrate fairness, integrity and objectivity and will be chosen on the basis of
28 expertise and personal experience relevant to the performance of the duties of the Board.
29 City Council shall appoint voting members who are representatives of the following
30 groups (though one member may be representative of more than one group):

- 31
32
33 i. at least three members who come from historically, racially or socially
34 marginalized communities that have commonly experienced disparate policing in
35 Alexandria or the Commonwealth of Virginia; and
36 ii. at least one member who represents an organization, office, or agency that seeks
37 racial or social justice or that otherwise advocates on behalf of historically,
38 racially or socially marginalized communities, particularly communities that may
39 have experienced disparate policing; ~~and~~

40
41 (c) Ex-officio, non-voting members:

- 42
43 i. at least one nonvoting, ex-officio member who shall have past experience in law
44 enforcement, but shall not be a current employee of or an immediate family

1 member of a current employee of a law enforcement agency and shall be at least
2 three years honorably removed from service.

3
4 ~~(b)~~(d) No voting or nonvoting member shall be a current or former City employee, a
5 current or former City elected official, a current candidate for public office, a current
6 employee of a law enforcement agency, or hold an elected public office, a former
7 employee of APD, or an immediate family member of any of a current or former APD
8 employee, a current APD employee, or a current employee of a law enforcement
9 agencythe preceding.

10
11 ~~(e)~~(e) Except as to the inaugural Board, members shall be appointed for terms of three-
12 years each, ~~which shall expire as of May 31~~. Board members' terms shall be staggered.
13 To that end, the City Council shall appoint three voting members of the inaugural board
14 to 18-month terms and four voting members to three-year terms. A Board member may
15 be appointed to no more than two consecutive three-year terms.

16 17 **Sec. 2-4-223 Conflicts of Interest and Confidentiality**

- 18
19 (a) The Board and each member shall comply with the Virginia State and Local Government
20 Conflict of Interests Act under Virginia Code §§ 2.2-3100 et seq.
21
22 (b) Except as included in the Board Reports defined in Section 2-4-221 (f) and to the extent
23 allowed under the Virginia Freedom of Information Act, each member shall maintain the
24 confidentiality of all confidential or privileged information, including but not limited to:
25 i. disciplinary actions, memos and reports that the member receives during service
26 on the Board.
27 ii. statements of a police officer, or APD employee, who was required by APD to
28 give a statement.
29 iii. criminal investigative files
30
31 (c) All original records provided to the Board by APD shall remain official APD records,
32 ~~and the permissibility of their release shall be determined by APD in consultation with~~
33 ~~the City Attorney's office, pursuant to applicable law.~~

34 35 36 **Sec. 2-4-224 Quorum, Voting, and Meetings**

- 37
38 (a) The Board shall comply with the procedures for Board and Commissions in Article A of
39 Title 2, Chapter 4, unless expressly amended in this Article.
40
41 (b) The Board, assisted by the Independent Policing Auditor/Investigator, is authorized to
42 develop and implement its own bylaws, administrative systems, and operating policies
43 and procedures, consistent with existing federal and state law, state regulation, and this
44 enabling ordinance. Such bylaws shall be subject to public notice and public hearing
45 before adoption by the Board and would become effective upon adoption by City
46 Council.

2 (c) The Board shall meet as often as necessary to conduct its business, but no less frequently
3 than four times per calendar year.
4
5 (d) Meetings of the Board shall comply in all respects with the meeting regulations of the
6 Virginia Freedom of Information Act including being open to the public except under
7 circumstances when the topic is authorized by the law to be discussed in closed session.
8
9 (e) To take any action, a quorum of at least five out of seven voting members must be
10 present.
11
12 (f) The Board shall keep minutes of its Board Meetings, and those minutes shall include:
13 i. the date, time, and location of each meeting;
14 ii. the members present and absent;
15 iii. a summary of the discussion on matters proposed, deliberated, or decided; and
16 iv. a record of any votes taken.
17
18 (g) The Board meeting minutes are public records and subject to inspection pursuant to the
19 Virginia Freedom of Information Act.
20
21

22 **Sec. 2-4-225 Support of Board**

- 23
24 (a) Board Staff
25 i. The city council shall appoint an Independent Policing Auditor/Investigator
26 pursuant to Section 4-1-5 and 4-1-6 of this Code who shall staff the Board and
27 coordinate the Board's administrative functions.
28 ii. The Independent Policing Auditor/Investigator shall hire such investigators as
29 shall be necessary to conduct the investigations assigned to the Board. Such
30 investigators may be consultants or full-time employees depending on the demand
31 for the investigations.
32 iii. The City Attorney, or its designee, shall serve as legal advisor to the Board. As to
33 a particular matter, and in the event the Board or the City Attorney determine that
34 there is a conflict of interest that precludes effective representation by the City
35 Attorney's Office, the City Board shall retain outside counsel to advise the Board
36 from a list of attorneys recommended by the City Attorney.
37
38 (b) Other Support from the City
39 i. A website shall be established for the Board hosted on the City's website. The Board
40 shall control what is posted on the Board's website to the extent it complies with all
41 applicable Federal, State and local laws.
42 ii. All public meetings of the Board shall be videotaped and made available to the public
43 on the City's website.
44 iii. The City shall not interfere unreasonably with the Board's decisions, assisted by the
45 Independent Policing Auditor/Investigator, to post materials to or remove materials
46 from the Board's website.

- 1 iv. Board members shall be provided with a City email address to be used exclusively for
2 Board-related matters.
- 3 v. The City, including all city departments, boards, commissions, and staff shall make
4 good faith effort to cooperate with and assist the Board, and shall comply with, ~~or~~
5 ~~expeditiously provide a reason for rejecting~~, all reasonable Board requests or
6 expeditiously provide a reason for rejection.

7
8 **Sec. 2-4-226 Board Training**
9

10 At least once every ~~two~~ years, and within six months of appointment to the Board, Board
11 members shall participate in the following training:

- 12
- 13 (a) at least eight hours of training, presented by the National Association for Criminal
14 Oversight of Law Enforcement or a comparable professional organization.
- 15
- 16 (b) Training by the applicable city staff addressing the following matters:
17
- 18 i. legal and ethical obligations of members of a public board;
 - 19 ii. APD policies and training, including but not limited to defensive tactical training,
20 Crisis Intervention Training, and de-escalation training;
 - 21 iii. relevant privacy rules and City policies and procedures involving liability,
22 employee discipline, and other matters related to police operations; and
 - 23 iv. APD and City administrative systems, processes, structures and operations.
- 24
- 25 (c) at least ~~three~~ ride-along sessions with APD patrol operations per calendar year.
- 26
- 27 (d) The City and the Independent Policing Auditor/Investigator, shall provide Board
28 members with additional training, which shall include but not limited to relevant training
29 by subject matter experts on mental health, trauma-informed policing, civil rights and
30 constitutional law, race and systemic racism, community organizing and outreach,
31 mediation, investigation, and policing practices, policies, and administration.
32

33 **Sec. 2-4-227 Board Duties**
34

35 (a) Board Readiness Resolution
36

- 37 i. Within thirty (30) days after the initial board members are appointed by the City
38 Council, the Board shall meet to establish its practices and procedures. When the
39 Board has established its procedures for how to take in Complaints, how
40 investigations will be conducted, the Memorandum of Understanding required
41 pursuant to Section 2-4-221(c) has been executed by all parties, and the board is
42 sufficiently staffed, it shall pass a Resolution indicating its readiness to take on the
43 responsibilities designated to it in this Article. No current processes for complaint
44 intake or investigations of complaints shall be transferred to the Board unless and
45 until such Resolution is adopted by the Board.

2 (b) Complaint Intake
3

- 4 i. The Board will develop and administer a process for receiving community complaints
5 regarding conduct of APD law enforcement officers and civilian employees and
6 referring complaints to APD or the Independent Policing Auditor/Investigator
7 depending on the nature of the complaint, for investigation. This process shall be
8 separate and distinct from any existing procedures by which the APD receives
9 community complaints as specified under Virginia Code § 9.1-600;
10
11 ii. Complaints filed with the Board may be submitted using a form provided by the
12 Board or may be submitted orally by a complainant. Complaints filed orally shall
13 capture the same information included in the complaint form developed by the Board.
14
15 iii. Information about the process for filing a complaint with the Board, complaint forms,
16 and general information about the Board and its purpose and scope shall be made
17 available online and at the office of the Independent Policing Auditor/Investigator,
18 APD, the Office of Human Rights, as well as other locations deemed effective for
19 making such forms and information widely available
20
21 iv. Information about the process for filing a complaint with the Board, complaint forms,
22 and general information about the Board and its purpose and scope shall be made
23 readily available in English, Spanish, Amharic and Arabic and in any additional
24 language as requested by an individual looking to submit a complaint to the Board.
25
26 v. Complaint forms shall request information regarding the incident including, but not
27 limited to, the following:
28 1) Name, address and contact information for the person filing the complaint;
29 2) a statement describing the reasons for the complaint;
30 3) the specific police behavior of concern;
31 4) a description of the incident in which the behavior occurred; and
32 5) information regarding witnesses to or persons with knowledge of the incident
33 known to the complainant, including but not limited to names, addresses, and
34 phone numbers, if known at the time the complaint is filed.
35 Failure to provide all information on the form by the complainant shall not render the
36 complaint unreviewable.
37
38 vi. This process shall be separate and distinct from any existing procedures by which the
39 APD receives community complaints as specified under Virginia Code § 9.1-600;
40

41 (c) Board Review of APD Investigations
42

- 43 i. Except for matters identified in subsection (d) herein, APD shall continue to
44 investigate all complaints submitted to APD or to the Board. APD shall ~~make good~~
45 ~~faith effort to~~ complete its investigation of the complaint and provide an investigation
46 report to the Board within sixty (60) days. The Board shall extend the 60-day period

1 upon request of the Police Chief to protect an ongoing criminal ~~or internal~~
2 ~~administrative~~ investigation, ~~while an employee filed grievance is ongoing under City~~
3 ~~Administrative Regulation 6-21, the Law Enforcement Officers Procedural Guarantee~~
4 ~~Act codified under Code of Virginia Title 9.1, or in a court of law,~~ or for other good
5 cause, with notice to the complainant and city council.
6

- 7 ii. The Board may review all investigations conducted by APD Office of External
8 Affairs and Professional Responsibility (OEAPR) regarding conduct of APD law
9 enforcement officers and civilian employees, whether received by the APD or the
10 Board, to ensure their thoroughness, completeness, accuracy, objectivity, ~~and~~
11 impartiality and the sufficiency of any discipline resulting from such investigations.
12 The Board may consider reducing the review to only a selected number of
13 investigations or investigations of a certain nature based on criteria to be articulated
14 by the Board and set forth in writing.
15
- 16 i. After completing an investigation review including a public hearing, the Board may
17 reach one of the following findings:
18
- 19 1) concur with all or some of the findings and determinations detailed in the
20 investigation report;
21
 - 22 2) advise city council, the city manager, and the APD that the findings are not
23 supported by the information reasonably available to the APD and recommend
24 further review and consideration by the police chief; or
25
 - 26 3) advise city council, the city manager, and the APD that, in the Board's judgment,
27 the investigation is incomplete and recommend additional investigation.
28
29
30

31 (d) Board Investigation of Complaints and Incidents
32

- 33 i. Investigations of the following incidents, whether they come in as a complaint or
34 not, shall be conducted by the Independent Policing Auditor/Investigator on
35 behalf of the Board:
36
- 37 1) "Incidents resulting in death" including any incident which results in death of any
38 person involved in the incident.
39
 - 40 2) "Use of Force" incidents, defined as the application of force sufficient to (i)
41 create a ~~substantial-reasonable~~ risk of death, (ii) cause serious and protracted
42 disfigurement, or (iii) result in impairment of the function of any bodily organ or
43 limb. It includes incidents in which a police officer deploys a striking implement,
44 Taser or similar device, oleoresin capsicum (pepper) spray or other chemical
45 irritant, less lethal weapon or a firearm or is applied using hands or any other part
46 of the body.

3 3) “Severe misconduct” defined as dereliction of duty or unlawful or improper
4 behavior which shall include the following offenses listed in AR 6-20, as the same
5 may be amended from time to time:
6 a. Willfully or negligently damaging, defacing or destroying City records,
7 City property, tools or equipment, or the property of another employee.
8 b. Theft, misappropriation or unauthorized removal of City records, or of
9 public property or of property belonging to another City employee.
10 c. Violating safety rules or the Virginia Traffic Code where such a violation
11 poses a threat to life.
12 d. Threatening or intimidating subordinates, fellow employees, supervisors
13 or members of the public.
14 e. Willful or serious neglect in the performance of assigned duties or in the
15 care, use, or custody of any City property.
16 f. Criminal or other misconduct occurring on or off the job which is related
17 to job performance or is of such a nature that to continue the employee in
18 the assigned position or in any City employment capacity would constitute
19 negligence in regard to the City's duties to the public or to other City
20 employees.
21 g. In any matter within the jurisdiction of any officer, department or agency
22 of the City: (a) the knowing falsification, concealment or cover-up of a
23 material fact, and/or (b) the knowing making of any false, fictitious or
24 fraudulent statement or representation, and/or (c) the making or using of
25 any writing or document knowing the same to contain a false, fictitious or
26 fraudulent statement or entry.
27 h. Sexual conduct, even consensual conduct, on the job.
28 i. Verbal or other conduct regarding an individual or group that maligns or
29 shows hostility for the individual or group because of race, color, religion,
30 gender, national origin, age, disability, ~~or~~ sexual ~~orientation~~orientation, or
31 gender identity and expression.
32
33 ii. If, after making a good faith effort to obtain, voluntarily, the attendance of
34 witnesses and the production of books, papers, and other evidence necessary to
35 perform its duties, the Board is unable to obtain such attendance or production,
36 the board by majority vote may direct the Independent Policing
37 Auditor/Investigator, on behalf of the Board, to apply to the Alexandria circuit
38 court for a subpoena compelling the attendance of such witness or the production
39 of such books, papers, and other evidence, and the court may, upon good cause
40 shown, cause the subpoena to be issued. ~~Any person so subpoenaed may apply to~~
41 ~~the court that issued such subpoena to quash it.~~
42

- 1 iii. At the conclusion of the investigation, the Independent Policing
2 Auditor/Investigator shall forward the file with a report of investigation to the
3 Board. The Board shall hold at least one public hearing on the investigation. At
4 the conclusion of the public hearing, the Board may take one of the following
5 actions:
6
7 1) Dismiss the complaint if, based on the file and report of investigation, it
8 determines that the complaint lacks merit or the incidents was justified;
9
10 2) Refer the complaint to the Commonwealth's Attorney for the City of Alexandria;
11 and
12
13 3) Recommend disciplinary action to be taken by the Chief of Police ~~in accordance~~
14 ~~with the City's disciplinary process.~~
15
16 iv. If the APD declines to implement the discipline recommended by the Board, the
17 Chief of Police shall, within 30 days of the Board's recommendation, create a
18 written record, which shall be made available to city council, the city manager,
19 and the public, of its rationale for declining to implement the recommendation of
20 the Board.

21
22 (e) Board Policy Recommendations and Duties

- 23
24 i. The Board shall have the following duties regarding review of police policy and
25 procedure:
26
27 1) review and evaluate existing and proposed APD administrative directives,
28 including all rules, policies, and procedures which direct the operation of the
29 APD and its employees;
30
31 2) review and evaluate reports issued and data collected by the APD related to
32 policing practices, policies, procedures, and outcomes;
33
34 3) receive, review and evaluate the annual budget and expenditures of the APD
35 and make budgetary recommendations;
36
37 4) advise city council on the hiring and annual evaluation of the Independent
38 Policing Auditor/Investigator;
39
40 5) recommend legislation, policy changes and other actions related to review and
41 evaluation conducted by the Board to the city council, city manager, APD,
42 school board, school superintendent, and other public agencies;
43
44 6) conduct community outreach in the city related to the review and reform of
45 policing practices, policies and procedures in Alexandria and the work of the
46 Board; and

2 7) undertake any other duties as reasonably necessary for the Board to effectuate
3 its lawful purpose to effectively review the policing agencies as authorized by
4 the city.
5
6 ii. The Board may recommend policies or procedures to city council, the city
7 manager and the APD concerning police practices, policies and procedures. The
8 Board shall present in writing its findings, and recommendations with supporting
9 rationale to city council, the city manager and the APD within thirty days from
10 the date the Board adopted the recommendations.
11
12 a. The Board's recommendations shall be included in any public reports issued
13 by the Board, including hardcopy and online.
14
15 b. If the APD declines to implement any changes recommended by the Board,
16 the Chief of Police shall, within 30 days of the Board's recommendation,
17 create a written record, which shall be made available to city council, the city
18 manager, and the public, of its rationale for declining to implement the
19 recommendation of the Board.

23 ~~(a) The Board and each member shall comply with all applicable Federal, State, and Local~~
24 ~~law and City Policies unless such City Policies are expressly amended in this Article.~~
25

26 **Sec. 2-4-229 Exclusions**

27
28 (a) The Board shall not consider claims or issues involving the following:
29

30 ~~i. Complaints involving any incident that occurred prior to June 9, 2020, the date that~~
31 ~~city council determined to establish the Community Policing Review Board.~~

32 ~~ii.~~ ii. Complaints involving any incident that occurred more than ~~six months~~two years
33 before the filing of the complaint with the Community Policing Review Board or the
34 APD;

35 ~~iii.~~ ii. Any financial management, or procurement decisions made by APD, or any
36 individual hiring, assignment and promotional decisions made by the APD;

37 ~~iv.~~ iii. If any agency having responsibility for criminal investigations or prosecutions has
38 initiated a criminal investigation or proceeding against any police officer or officers
39 who are the subject(s) of an incident or complaint that the Board has responsibility for
