Please use the attached link to download the design progress for the upcoming DRB presentation on 1/15/2015.

The revisions include:

Site Design

- The curvilinear entrance ramp is better integrated with the entry walkway. The wall-like element between the walkway and the ramp is removed and replaced by a gradual grass berm. Cable railings are

used to increase the transparency between the two areas. The perimeter fence is relocated to behind the ramp which further improves the integration of the ramp and the walkway.

- We studied the option of using a low anti-ram wall with a regular fence (instead of a rated K12 one). This option is illustrated in the alternate site plan and site section.

Building Design

- The entry overhang is further developed and extended to serve both the functional and visual aspects of the entrance.
- The west façade is further developed to include colors on the recessed 'notch' to create further visual interest.

We will also add windows at the precast 'return' walls on levels 15 and 16 where the notch is located for the presentation on the 15th.
