#### 4 Community Comment Period

• There were no written or verbal comments submitted to the Subcommittee by community members.

#### 5 Review of Meeting Agenda and Objectives

• Mignon Anthony, Chair, welcomed Subcommittee members and made introductory remarks.

### 6 Discuss and Confirm Subcommittee Objectives

- Subcommittee members discussed the broad nature of the Subcommittee topic and possible focus areas as meetings progress.
- Mr. Millard specified that he would like the Subcommittee to consider real estate opportunities for long-term planning. Mr. Dunton concurred.
  - Examples given were utilizing Victory Center on Eisenhower Avenue for City staff; and (re)assessing the Torpedo Factory's potential to address some of the issues discussed
- Ms. Anthony indicated that representatives from Alexandria Economic Development Partnership intend to be present at the next Subcommittee meeting to discuss projects currently under their purview.
- The Subcommittee requested that staff identify projects in the City that are adjacent to projects under the purview of the Joint Task Force.
- Subcommittee members will consider civic engagement and the timeline for engagement throughout project delivery.

# 7 Alternative Project Delivery Methods Best Practices

- Consultants from Brailsford and Dunlavey facilitated a discussion on best practices in alternative project delivery methods and aligned vernacular within the field.
- Mr. McPike explained the statutory environment for Virginia and the City of Alexandria with regards to alternative project delivery methods. Mr. McPike answered specific questions raised by Subcommittee members.
- Ms. Lewis explained the process for ACPS projects to utilize alternative project delivery methods and examples of projects that have done so. Ms. Lewis answered specific questions raised by Subcommittee members.

### 8 Discussion / Observations to Date on City and School Practices and Processes

- Subcommittee members discussed themes and observations of the current use of alternative project delivery methods by the City and ACPS.
- Mr. Dunton indicated that he desires to see more high risk/high reward project solutions as an option. He believes some solutions are not considered as they have higher risk than others.
- Ms. Anthony indicated that she wishes to explore synergies between current and potential projects.
- Mr. Millard expressed his interest in determining overlap between the mission of a public agency and potential partner, similar to a Venn Diagram.
- Based on discussion, the Subcommittee intends to consider the following topics during this process:
  - Recommend project models for the City consider for future projects, including
    - Alternative strategies
    - Implementation approaches and delivery methods
    - Alternative financing opportunities
    - Public private partnerships ("P3")
    - Other alternatives beyond P3

- Identify real estate opportunities, both selling and purchasing, within the City
- Outline how the current administration interfaces with proposed projects
- Identify strengths and/or weakness of both public and private partners
- Opportunities for colocation and/or joint use and the projects are best suited for such alternatives
- Civic engagement as related to each topic
- During discussions, the Subcommittee requested the following additional information:
  - Projects currently under the purview of Alexandria Economic Development Partnership
  - Comparison of current projects in the city and forthcoming projects to identify potential synergies
  - Information on Low-Income Housing Tax Credits (LIHTC) and how it has been used in Alexandria
