Discussion Summary

- 1. *Call to Order:* Mr. Stensrud welcomed everyone and began the meeting at 7:10 p.m. Mr. Stensrud asked that the agenda for the meeting be changed, by taking the Advocacy and Outreach Report off of the agenda, and placing the Torpedo Factory Art Center Engagement report on the agenda.
- 2. *Public Comments:* Mr. Matthew Stensrud welcomed the Arts Commissioners and the members of the audience to the meeting.

He invited Ms. Kelley Organek, Upcycle Creative Reuse Center to speak. Ms. Organek shared the following:

- Background about Upcycle Creative Reuse Center
- Concern about the classroom rental increase from 20% of cost to 50% of cost as of July 1.
- Requested possible freeze of the increase until the calendar year rather than July 1.
- Increase of rental fees may result in fewer programs offered by Upcycle at the Durant Arts Center.
- Request for delaying increase 30%, 40% then 50%

Office of the Arts staff stated:

- Durant Arts Center is the only Center that has not implemented the City Council Cost Recovery Policy for requesting renters to pay 100% of total cost for renting Center. This is against Policy.
- At the December 2014 Arts Commission meeting, the Arts Commission approved the staff's recommendation for regular users to be 20% of rental fees for Fiscal Year 2016 with the 50% of rental fees for Fiscal Year 2017 (this year), and 100% to occur beginning as of July 1, 2017.
- During Fiscal Year 2017, to raise revenues to off-set reductions was not part of the budgetary process. This option was part of the Fiscal Year 2018 budget process.
- In the Fall, the Office of the Arts will be exploring leasing of the classroom spaces for other tenants who would offer programming for the Center.

Commissioners discussed the Cost Recovery Policy and how it affects the grantees renting the Center. The Arlington Cultural Affairs model for offering space as part of their grant program was also explored.

Mr. Stensrud thanked Ms. Organek for her comments. He also thanked the Arts Commissioners for their comments on this issue. He stated that this Cost Recovery Policy is a City Council approved Policy and that the Office of the Arts staff is implementing this Policy.

- 3. *Chair's Report:* Mr. Stensrud distributed the monthly Chair's Report (**ATTACHMENT #1**). Highlights from the report include:
 - Mr. Stensrud had a letter to the editor published in the Alexandria Times.
 - Advocacy into the Future This could be a topic of discussion at the retreat. It could also be something that could be discussed monthly both at the Executive Committee and regular Arts Commission meetings. The Arts Commission should involve the arts organizations and the Arts Alliance in these advocacy efforts.
 - New Logo- Ms. Allison Nance has volunteered to create a new logo for the Arts Commission. This is a work in progress.
 - Summary from the Torpedo Factory Engagement meeting is now online.
 - Mr. Stensrud attended Mayor Allison Silberberg's birthday party.
 - He also participated in the Alexandria Earth Day Celebration.
 - Mr. Stensrud will be teaching Music at George Mason Elementary School in the Fall.
 - Reminders:
 - Arts Commissioners should be sending their annual report information to Ms. Nance.
 - The Arts Commission's retreat is Saturday, August 26. More information to report once available.
- 4. *Approval Minutes*
 - a. March 21st Regular Meeting, Approved by Consent.
 - b. April 18th Regular Meeting, Approved by Consent.
- 5. Committee, Task Force & Liaison Reports:
 - a. *Nominating Committee:* Mr. Michael Detomo reported that the Nominating Committee met and developed the slate of officers for Fiscal Year 2018. The Nominating Committee members were: Mr. Michael Detomo, Ms. Sara Lavan and Ms. Gayle Converse. Mr. Detomo presented the following slate of officers. He stated that the vote for the slate of officers will take place at the June 20 meeting. At that meeting, nominations from the floor will also be accepted.
 - i. Presentation of Slate for Fiscal Year 2018
 - 1. Chair: Matthew Stensrud
 - 2. First Vice Chair: Allison Nance
 - 3. Second Vice Chair: Catherine Barrett
 - 4. Secretary: Karen Thomas

Mr. Stensrud thanked the Nominating Committee for their service. He invited the Nominating Committee members to attend the next Executive Committee meeting so they can share insights in how to grow leadership in the Arts Commission. He wanted too, to explore with them, how the Arts Commission can put in place, systems which will allow for Arts Commission leadership training.

Mr. Stensrud mentioned that after the vote is taken at the June 20 meeting, that the Nominating Committee would be dissolved. Officers will take office immediately.

- b. Advocacy and Outreach: Taken off the Agenda.
- c. Arts Education: Ms. Beth Coast reported that the Arts Education Committee met with Mr. Andrew Watson, Fine Arts Specialist with the Alexandria City Public Schools (ACPS). He informed the members that ACPS is looking for instructors to provide private lessons. This might be funded through the PTAs. ACPS is working with developing an ongoing "arts" T.V. program. He wishes to have art groups be involved with the T.V. program. Mr. Watson is planning to work with the Arts Education Committee and the City-wide Art Exhibition to have a presence during next Spring's Youth Arts Month (March).

- d. Grants: Ms. Allison Nance informed the members that the planning for the Fiscal Year 2019 grant cycle will begin at the June 12 Grants meeting. At this meeting, the grant cycle's calendar will be reviewed, and brainstorming for changes will be explored. The Grants Committee members include: Ms. Nance, Ms. Catherine Ahern Barrett; Ms. Karen Thomas, Mr. Michael Detomo, Ms. Lisa Baranello, and Ms. Regan Spurlock. Ms. Nance also reported that the Virginia Commission for the Arts has informed all Fiscal Year 2018 Local Government Challenge grant recipients that their grants will be reduced by 10%. A revised funding scenario will be discussed later on the agenda.
- e. Alexandria Arts Alliance: Ms. Amber Gordon shared that the Arts Alliance had a great turn-out for their April 18 social media workshop. She also mentioned that the Arts Alliance is planning a Spring Summit. The theme/topic will be art and history. Ms. Patricia Washington, Visit Alexandria and Mr. Lance Mallamo, Office of Historic Alexandria are both assisting with the planning efforts. All of the cultural arts organizations/groups will be invited to participate in and at the Spring Summit. The Summit will also be a membership meeting for the Arts Alliance.
- *f. Waterfront Commission:* Ms. Susie Cohen informed the members that the discussion topics at the Waterfront Commission meeting were:
 - Development progress for both Robinson Terminal North and South.
 - Dominion Boat Club will be moving in to their new facility in the Fall.
 - Interim Fitzgerald Square will have some development in the summer, but most-likely in the Fall.
 - El Galeón," an authentic replica of a 16th-century Spanish Galleon, will be in Alexandria from May 25, through May 29.
 - The annual waterfront walk will occur on Saturday, June 3. If you wish to participate, check in with Ms. Cohen, she will provide the starting point location.
 - Indigo Hotel has a new sculpture, Christopher Erney is the artist.
 - City Council approved a new Marriott Hotel that will be placed at the corner of Harvard and King St.
- g. Torpedo Factory Engagement Process: Two meetings have been held, one with the consultants Diane Mataraza and Surale Phillips. At the meeting, a discussion of strategies, hope and expectations of each member was held. It is anticipated that there will be opportunities for community engagement through a survey that can be completed online, and possibly too, in person. The Engagement Process is anticipated to run through the first weekend in October, ending with Art on the Avenue. The next Torpedo Factory Engagement Process meeting is scheduled for June 13 at City Hall. To receive regular updates of the Torpedo Factory Engagement process, periodically, visit the website: www.alexandriava.gov/TorpedoFactory
- 6. *Task Force and Committee Appointments:* Mr. Stensrud mentioned that this appointment will be delayed one month. There are internal discussions for candidates. Ms. Nance provided a name for a P.T.O. representative.
 - a. Duke Street Tunnel
 - i. Motion to Appoint Members
- 7. Recess occurred 8:26 p.m.- 8:30 p.m.
- 8. FY2018 Grants Adjustment: Ms. Ruggiero distributed the Office of the Arts staff memorandum (ATTACHMENT #2) that outlined a funding scenario "N."
 - a. *Discussion and Motion:* The adjustment to the reduction occurred across all grant applicants. A motion was made, seconded and unanimously approved to accept scenario "N" funding recommendations (MOTION #1).
- 9. *Public Art Work Plan:* Mr. Stensrud informed the members that the CIP funding was not restored during the Fiscal Year 2018 budget process. Because of this, the Arts Commission will need to adjust its work plan for Fiscal Year

2018, 2019 and 2020.

- a. *Review of Final CIP Budget:* The Arts Commission approved work plan was distributed. Ms. Ruggiero informed the members that consultants will be preparing program plans for the Fitzgerald Square, AlexRenew and the Trails and Paths.
- b. Discussion on Possible Adjustments: Ms. Ruggiero walked through each of the CIP projects. An open discussion occurred. Items discussed included:
 - Can each project be cut a little so each project could happen.
 - Should all the money be used to make a big artistic statement for the next 2-3 years.
 - Do Fitzgerald Square in 2 years, but funding might be taken away.
 - Do not do smaller projects such as traffic boxes.
 - Prove that public art makes a difference so the decision-makers get it.
 - Look at projects that best support the Arts and Cultural Master Plan, and cut projects that do not support the plan.
 - Try to keep projects in low resource areas or economically challenged areas.
 - Do projects that have the biggest impact projects can be big or small but should have an impact.
 - Public art should be high quality. Need to develop a way to quantify and create value for having public art in the City.
 - Need to partner with businesses, and neighborhoods to show the impact, must be demonstrated with data.
 - Try to keep project that work or have worked. Work with partners such as AlexRenew, Arlandria and the Alexandria City Public Libraries.
 - Create highly visible projects.
 - Don't lose sight of creative directions and geographic diversity as outlined in the Public Art Implementation Plan.
- Mr. Stensrud said that the Arts Commission will vote on what project to adjust or not do, at the June 20 meeting.
- 10. Office of the Arts Staff Report: Ms. Ruggiero distributed the May Office of the Arts report (ATTACHMENT #3). Report highlights:
 - Time and Place reception/event will be held Saturday, May 20. Another artist event will be held in July.
 - Lake Cook Project Ms. Allison Heck attended the open house, as did 8 people. On June 15 from 7 p.m. to 9 p.m. at the Alexandria Police Headquarters, 3600 Wheeler Ave., there will be another open house to discuss the proposed public art piece, part of the Lake Cook Stormwater Retrofit project. The City of Alexandria has commissioned Baltimore-based artist David Hess to design a unique public art piece at Lake Cook.
 - Freedmen's Cemetery public art pieces have been cleaned and repaired. Mr. Matthew Harwood led these efforts.
 - The World War II Memorial has also been cleaned.
 - The Community Support Art project will have a launch party in late June. The "call for artist" generated 87 applications. A pick-up party will occur in September/October.
 - The WorkPlan Taskforce will meet in July and August. Watch for a meeting invitation.
 - The AlexRenew Residency Task Force members Ms. Amber Gordon and Ms. Sara Lavan will meet over the summer.
- 11. New Business:
 - Ms. Beth Coast reported that the Congressional Art Show is current up at the National Arts Education Association (900 Prince St).
 - Mr. Stensrud reported that he provided language, specifically, "explore the possibility of an arts district" for the Old Town North project. He mentioned that the Executive Committee will review the Small Area Plans and determine if new members might need to be appointed.
- 12. Good of the order and Announcements:
 - The Torpedo Factory Center's Board will have their last meeting in June, to dissolve the Board.

- Ms. Amber Gordon reported that the Indigo Hotel staff have volunteered to give tours of their facility over the summer. They are officially opening as of June 6. She will work with the Hotel staff and the Arts Commissioners to find a mutually agreed upon date.
- AlexRenew also offered to give tours of their facility. Ms. Amber Gordon will work with the AlexRenew staff to find a mutually agreed upon date.
- Plans are underway for the 2017 Ethiopian New Year Celebration.
- Ms. Colton reported that the Music Through The Ages: Gospel and Barbershop is scheduled for Friday, May 19
 and Saturday, May 20 at the Durant Arts Center. After the Music Through The Ages event on Saturday, the
 Harmonizers will have an Armed Forces Day Center.
- 13. *Adjournment:* Mr. Stensrud mentioned that all items were addressed from the meeting's agenda, so the meeting adjourned at 9:15 p.m.

RE: FISCAL YEAR 2018 ARTS GRANTS - FUNDING

Background:

The Virginia Commission for the Arts (VCA) provides annual funding to the City of Alexandria Arts Grant Program through their Local Government Challenge Grant. The VCA notified grant recipients on April 20, 2017 that the FY18 grant award amount of \$5,000 would be reduced to \$4,500.

Discussion:

The funding level for FY18 is now \$170,000 from the City of Alexandria and \$4,500 from the VCA. This reduction impacts the amount of funding Alexandria Arts Grant Recipients receive and requires the Alexandria Commission for the Arts (ACA) to adjust the grant awards that were voted on at the April 18, 2017 meeting.

Staff has developed an alternate funding scenario (Scenario "N") for consideration by the ACA.
