## Soft Play Room Rules



- Admission for the Soft Play Room (SPR) is \$5.00 per child per half-hour for first child and adult.
- Additional half-hours may only be purchased at the end of the first half-hour. If the SPR is at maximum capacity, patrons will be added to the end of the waiting list for reentry.
- One chaperone free per child. Additional chaperones will be charged \$1.00 per resident and \$4.00 per non-resident. Additional chaperones will not be permitted when SPR is at maximum capacity.
- <u>The SPR capacity is 16 persons (combination of children and adults totaling 16)</u>. A maximum of 5 children per chaperone is required as mandated by Fire Marshall.
- Children must be supervised at all times. Never leave children unattended in the SPR. Chaperones are required to remain in the playroom and supervise play at all times.
- Due to Health Code Regulations children & chaperones must remove their shoes while in SPR.
  <u>SOCKS ARE REQUIRED AT ALL TIMES.</u> Bare feet and outdoor shoes are not permitted.
- Due to Health Code Regulations diapers are not to be changed in SPR.
- Food, drink, and gum are not allowed in the SPR.
- Knives, scissors, or anything that can puncture equipment are not permitted in SPR.
- It is important all equipment remain in its original place in SPR for safety reasons. Please help keep the SPR neat.
- Outside toys or games are not allowed in the SPR.
- Children over age five or taller than 45 inches are not permitted in SPR.
- Seating is available at entrance of SPR for chaperones. Chaperones may not stand or sit on SPR equipment, or in the ball pit or on its sides. This equipment is not designed for adult capacity and will tear or break.
- Participants are required to produce an admission receipt upon request from the Manager-On-Duty or SPR monitor.
