(1) Waterfront Core Area

- A. For the Waterfront Core Area, Option C successfully captures the best elements of Alternatives A and B.
- B. For the Waterfront Core Area, Option C represents an appropriate scale and character for Alexandria.

(2) For the Waterfront outside the Core Area, the improvements proposed for parks and public improvements are an appropriate scale and character for their areas:

- A. Founders Park – The improvements proposed for Founders Park are at an appropriate scale and character for the area.
- B. Oronoco Bay Park – The improvements proposed for Oronoco Bay Park are at an appropriate scale and character for the area
- C. Rivergate Park – The improvements proposed for Rivergate Park are at an appropriate scale and character for the area.
- D. Tidelock Park – The improvements proposed for Tidelock Park are at an appropriate scale and character for the area.

(3) For the Waterfront Planning Area, as a whole, the design has the right balance of spaces with shade vs. sun, spaces for programmed activity vs. non-programmed activity, and spaces for amenities and recreation.

(4) For the Waterfront Planning Area, as a whole, connectivity to and along the Waterfront Planning Area has been enhanced through improved pathways and walkways, seating options, and view corridors.

(5) Examples of the common elements that are proposed for lighting, furnishings, and paving materials reflect the character of the Alexandria Waterfront.

(6) The concepts for site integrated art further enhance the character and historic background of the Alexandria Waterfront.
